Subject: Evolving Incident Management (EIM) – Implementation Phase

We are pleased to welcome you as a Work Unit Lead or Task Unit Lead for the Implementation Phase of Evolving Incident Management (EIM). You have been asked by the NWCG Executive Board to serve on this EIM Implementation Team. You were selected because of your leadership background, position, and experience with incident management. While your agency perspective is important, we are asking that you represent the goals of interagency incident management for this assignment.

Background:

In December 2011, the National Wildfire Coordinating Group (NWCG) Executive Board accepted the Incident Management Organization Succession Planning (IMOSP) Team's Report, *"Evolving Incident Management: A Recommendation for the Future,"* following a two-year analysis. In February 2012, the NWCG Executive Board chartered a second interagency Task Team to develop a Strategic Implementation Plan (SIP) as Phase 2 of Evolving Incident Management (EIM). The purpose of the SIP was to outline the implementation steps and timelines that are needed over the next five (5) years to implement the recommendations and Overarching Principles (OAP) contained in the IMOSP Report. You will be involved in the

Implementation Phase (Phase 3) of Evolving Incident Management. More information can be found at http://www.nwcg.gov/imosp/index.htm.

The Team:

The EIM Implementation will be led by an Implementation Project Leader. You will be providing leadership and oversight for one of the eight (8) work units as a Work Unit Lead or Task Unit Lead. The IMT Pathway Work Unit will have two co-leads. In addition, each work unit will have a NWCG Executive Liaison assigned to that unit who will provide support as needed. Recommendations for additional resources can be found in the "*Phase 2 Strategic Implementation Plan Matrix*" (see Attachment B).
