



 IMT Course Steering Committee (IMTCSC) Monthly Update: Numbering of S-320 assigned to Introduction to Incident Management Teams (IMTs) course. Alpha pilot course in June in Sacramento. Beta course in September in Madison, WI. 	N/A
 Operations Branch Director (OPBD): Operations Section Chief Type 3 (OPS3) will not be included in the required experience as part of the qualification pathway to OPBD.  OSHA Emergency Response Standards Discussion: DOI/USFS are providing comments on the proposed OSHA standards for Emergency Responders and is requesting that NWCG draft a position paper on the implications of NFPA standards. Would like to anchor to NWCG standards vs. adopting NFPA standards. Trying to communicate between federal agencies with Occupational Safety and Health Administration (OSHA) and federal wildland fire agencies. Emphasize that not all National Fire Protection Association (NFPA) standards apply to wildland fire. 	Kat Navarro to draft a comment letter from NWCG EB to OSHA broadly explaining the difference between structural and wildland needs for firefighters and the role that NWCG plays in the development of interagency standards.
