<ul style="list-style-type: none"> <li>• FireFly- provides information for sources on suspected wildfires to National Guard units. Which get analyzed and provides location to State and Geographic Coordinating Groups (GACC).</li> <li>• FireGuard- National Interagency Fire Center (NIFC) and National Guard working together to improve wildfire detection and monitoring. Uses Hawkeye and FireFly together.</li> <li>• California and Colorado National Guard stood up pilot project.</li> <li>• Detection are categorized by date and time.</li> <li>• Click on polygons to view data. Firefighters can update data with mobile devices.</li> <li>• Mammoth Pools- FireGuard assisted in the evacuation of campers entrapped by showing escape routes available.</li> <li>• All data will be stored and can be searched.</li> <li>• FireGuard notifications can be SMS or email.</li> <li>• Plan on integrating FireGuard further with existing planning and operational processes.</li> </ul>	
<p><b>Data Management EDG Update:</b></p> <ul style="list-style-type: none"> <li>• Search terms by type or related concepts link and diagrams terms.</li> <li>• Representation of data in our environment.</li> <li>• Glossaries- show relationships and links between terms. Business rules are applied to terms. Tracible to applications and back to policy.</li> <li>• Reference data- important to manage. Previously managed.</li> <li>• IROC and IQCS will be able to read data from EDG.</li> <li>• PMS 310-1 is in EDG.
