### **Summary:**

The analysis team determined that:

- PSC1 no endorsement recommended due to necessity of prior wildland fire
  experience and the potential for significant increase in number of resources assigned
  to type 1 incidents.
- PSC2, DOCL, RESL endorsement recommended. The endorsement will include additional NWCG requirements as identified above.
- PSC3 no endorsement recommended due to the prerequisite wildland fire knowledge and experience required of a wildland fire Planning Section Chief Type 3.
- DMOB, SITL no endorsement recommended due to the prerequisite wildland fire knowledge and experience required of a wildland fire Demobilization/Situation Unit Leader.
