Fatalities, Entrapments and Serious Accident Summary for 2011 (http://www.nwcg.gov/branches/pre/rmc/)

The following data indicate the fatalities, entrapments, burn-overs and other life-threatening accidents and injuries associated with wildfire in calendar year 2011. The information was collected by the NWCG Risk Management Committee, with confirmation of the fatalities from the National Fire Protection Association (NFPA).

For calendar year 2011 there were (11) fatalities:

Medical Emergencies: (4) One FF had a heart attack two hours following fire training. Two FFs died from hyperthermia. One FF found deceased from a heart attack.

Entrapment/Burnover: (4) One FF was entrapped and received severe burns and succumbed to injuries 11days later. Two FFs were burned over while conducting tractor/plow operations. One FF was burned over during initial attack.

ATV: (1) One FF died when ATV collided with pickup truck.

Hazard Tree/Snag: (1) One FF received severe brain injuries and 2nd degree burns to his legs when he was struck & rolled downhill by a snag.

Other: (1) One FF was entrapped and was trying to seek safety when struck by vehicle on road.
