Fatalities, Entrapments and Serious Accident Summary for 2013 (http://www.nwcg.gov/branches/pre/rmc/)

The following data indicate the fatalities, entrapments, burnovers and other life threatening accidents and injuries associated with wildfire in calendar year 2013. The information was collected by the NWCG Risk Management Committee, with confirmation of the fatalities from the National Fire Protection Association (NFPA).

For calendar year 2013 there have been (34) fatalities:

Driving: (3) 1 FF died in a vehicle/tree collision while responding to a fire in SC. 1FF died when contract water tender left

roadway and rolled down embankment in OR. 1FF died in an ATV crash in NM.

Entrapment/Burn over: (19) 19 FFs died in a fire in AZ.

Medical Emergencies: (8) 1 FF died following a response to a brush fire in TN. 1 FF died on initial attack in NC. 1 FF died when struck

by vehicle on a NJ prescribed fire. 1dozer operator died while building fire line in ID. 1 FF died after returning from a brush fire in SC. 1 FF died while taking WCT in NM. 1FF died while constructing dozer line in OR.

1FF died while rehabilitating fireline in CA.

Hazard Tree/Snag: (3) 1 FF died when struck by a falling portion of a tree in CA. 1 FF died after being struck by snag in OR. 1FF

died when struck by a burned out tree (not a felling incident).

Aviation: (1) 1 FF died when parachute failed to property deploy during a research & development jump.

The Risk Management Committee would like to request any Fire Agency/Organization that experiences a fatality(s), or entrapment(s) to follow the guidance provided in National Mobilization Guide, Chapter 20 page 48 Wildland Fire Entrapment / Fatality. In the event that a wildland fire entrapment or fatality occurs, it should be reported immediately to the National Interagency Coordination Center (NICC). A Wildland Fire Entrapment/Fatality Initial Report should be completed and sent to the NICC electronically or by fax within twenty-four (24) hours.
