- Achievements: ABRO is done! Six other positions are nearing completion this summer.
- Risks/Challenges: Scheduling becomes more challenging during fire season.
- Next Steps: Planning Phases 3 and 4 for the 2025 Rodeos. Finalizing the dashboard for sharing out progress.
- Upcoming Positions: Numerous positions coming up. The goal is to spread them out so that they do not overload any one committee or function.

## New or Significant Changes to Incident Positions:

- Tactical Pause Memo

  - Fire Prevention Education Team Subcommittee (FPETSC):
    - No updates
  - Public Information Officer Subcommittee (PIOSC):
    - New chair: Kerry Green. Vice Chair: Katherine Cole.
    - IPTM: PIOT & PIO3 will be reviewed during meeting in July.
  - Wildland Fire Investigation Subcommittee (WFISC):
    - Submitted four proposals to Joint Fire Science Program.
    - The Guide to Wildland Fire Origin and Cause Determination, PMS 412, update is in progress.
    - Looking for guidance from EB on if their documents should go out for review. Would like time with the EB to discuss wildland fire investigation.

  - Cache ordering publications are being updated with prices.
  - UTV typing standards: form will be coming out via distribution channels.

- IRPG update is happening for 2025.
- S-320: Introduction to IMTs:
  - Alpha pilot course completed in Sacramento. The lessons learned will be applied to the beta pilot for September in Madison, WI.
  - The advanced course will start analysis this fall to work toward the Dec 2025 deadline (reminder: Field Eval goes away in Jan 2025).
- Change to safety zone calculation field test information is on the IPSC website, under "Useful Resources."

  - o 2025 SIIBM Incident Business Guide was released and the summary of changes are out.
  - New shift ticket (OF-297) is out. Electronic version is available; printed is not yet. Old, printed forms will still be valid for 2025.
  - Videos in progress: new shift ticket and yellow book.

  - Working on new design for Lead by Example Award. Presented a lifetime achievement award.

  - Big Swamp/Rum Creek (TM 24-003 and 24-004): Working with EMC and NIAC.
  - Still working on Safety Officer task books and positions.
  - Fatigue Management recommendations presented to FMB. Research is ongoing and looking for ways to implement best practices.
  - Memo from EB released about Environmental Hazard definition and mitigation strategies for wildland firefighters in response to a BIL tasking.
  - OSHA's Emergency Response Standard public review work continues.
  - Draft safety bulletin for respirators is with committees and has highlighted the complexity of proposed protection measures.
