Developed by FWS and expanding to support other federal bureaus and agencies. Exploring collaboration with Boise State University's leadership program. Courses will be available in the learning portal, expanding access to federal, state, and local government personnel. Three phases: first two are virtual, third is in-person.</li> </ul>	
<ul> <li>Tactical UTVs</li> <li>Forest Service is seeing a lack of standardization of specifications for tactical UTVs.</li> <li>Stemmed from AIMS and contracting side of the house.
