Global Changes

- Remove X-520, NWCG CIM Field Evaluation
- Replace Safety Officer Line, SOFR with Safety Officer Type 3, SOF3

Safety Officer, Line – SOFR

• Name updated from Safety Officer Line, SOFR to Safety Officer Type 3, SOF3 (IPSC-2024-09)

Fire Behavior Analyst - FBAN

- Required Training:
 - o Add S-491 Intermediate National Fire Danger Rating System (IPSC-2024-08)
- Other Training which supports the development of knowledge and skills:
 - o Remove S-491 Intermediate National Fire Danger Rating System
 - o Add None

Incident Commander Type 1 – ICT1

Assistant Area Commander Planning - ACPC

- Required Experience:
 - Update first bullet with Satisfactory performance as an Incident Commander Complex (ICCI), or Operations Section Chief Complex (OSCC), or Planning Section Chief Complex (PSCC), or Logistics Section Chief Complex (LSCC), or Finance/Administration Section Chief Complex (FSCC)

The position qualification requirements on the individual position pages of the <u>NWCG Position Catalog</u>, www.nwcg.gov/positions-catalog, will be updated, and position qualification requirements changes will be effective in the qualifications systems on January 24, 2025.
