2021-11, additional training requirements for PETL and PETM positions

Purpose: This memorandum approves the content of Incident and Position Standards Committee (IPSC) Request for Change (RFC) 2021-11 received from the Fire Prevention Education Team Subcommittee.

Action: Prevention Team Leader (PETL) and Prevention Team Member (PETM) will have additional training requirements applied in the NWCG Standards for Wildland Fire Position Qualifications, PMS 310-1 on July 1, 2022. Additions are as follows:

- PETL: add P-410, Fire Prevention Education Team Leader as required training.
- PETM: add P-310, Fire Prevention Education Team Member as required training.

No action is required for currently qualified PETL's and PETM's; these responders will remain qualified. Those PETL and PETM responders who are trainees on July 1, 2022, will be required to complete the additional required training prior to position certification.
