**Subject:** Approval of Incident and Position Standards Committee Request for Change

2021-03, Public Information Officer, Type 3 (PIO3)

**Purpose:** This memorandum approves the content of Incident and Position Standards Committee Request for Change 2021-03 received from the Public Information Officer Subcommittee.

**Action:** Effective, January 2023 implementation of the new position standard for Public Information Officer, Type 3 (PIO3) has been approved. At the same time, the Public Information Officer (PIOF) will be discontinued and transition to PIO3.

**Current Qualified PIOF:** The process of historical recognition for the PIO3 position will be used for all current qualified PIOF upon updates to the NWCG Position Catalog in January 2023. All qualified responders will be transitioned from PIOF to PIO3 and will follow the new currency requirement as of the transition date.

**Current Trainee PIOF**: Current PIOF trainees will transitioned to a PIO3 trainee status in January 2023. The trainee will need to meet the new qualification standard for PIO3. Trainees will transition to the new PIO3 position task book (PTB); however, documentation of the position performance in the PIOF PTB should still be considered toward certification. Trainees initiating a new PTB after January 2023 will use the new PIO3 PTB.
