- NWCG Coordinator remarks and news and update Deb: Katie Wood is new program manager and is getting up to speed quickly. Almost 50% of staff is vacant.
- Fire Prevention Education Team Subcommittee update Gwen:

So Far there have been four teams that have been deployed, one upcoming placement and only one still out:

Southwestern US, Tonto NF: Team Thibideau

Southern Colorado – Pike San Isabel NF: Team Funk

Northern Colorado – Arapaho and Roosevelt NF: Team Beavans

Southern Colorado – Pike San Isabel NF: Team Grimes (still active)

California – Team Hecker (about to be deployed)

The FPET SC Chairs, liaison and others met with NICC and NFS Operations Assistant Director and discussed various options for how to manage FPETs in the future. Tina, Gwen, Fred and Zach need to meet to determine a path forward.

FPET webinar was held May 13 2021 and was hosted by the FL Division of Forest Service FPET. There will be an AAR of the P-310 Beta test this Thursday. The hope is that this will then go to final certification and be officially available on the Learning Portal.

IPD for PETM and PETL did not have any comments and we've decided to close them, however they are always open for comment.

• Wildland Fire Investigation Subcommittee update – Shaun:

Jerry was teaching, so Shaun Zimmermaker presented. I-210 being taught this week over the learning portal and they will see how that will go. Updating FI 410, and FI310 will be beta-tested in Reno, in November.

• PIO Subcommittee update – Candy:

PIO technician position approved!! Contact Candy if you have any comments or concerns you have not shared yet.

All hazard was not approved at the PIO(1) level. A lot of people were not familiar with it and it was taught more as a CA-based course. Mike Ellsworth, on the IPSC, will be looking at complex incident management teams and associated requirements, and looking at training PIO2s vs PIO1s. Next steps = looking at reviewing PIOF task book and bring it up to PIO3. Also, there are 46 positions that are shared with All Hazard. The intent is to go through these positions to provide endorsement for the All Hazard positions to work in Wildfire. Need to see what is different, and what is the same.

PIO(F) taskbook to be brought up to speed for the IPD. Many of the revisions are done, but it is not final. Hope to get it to CEPC to review prior to IPSC deadline. PIO can be AH (all-hazard) or WF (Wildfire).

Topic

Data standards and Fire Restriction Maps: Tina will get a meeting set up. There are issues with the amount of data that can get hosted on NIFC site. They don' have the bandwidth to update all of that. It would be best to just link to the GACCs. Some places are going to have a hard time meeting a data standard for creating a fire restriction layer. Data management will be an issue as well, and website management; trying to keep everything up to date would be cumbersome.

Leader Handbook: We need to get this on the top of our list to accomplish our task. Gwen is going to see if she can hire a temporary to do some of this work for the committee. Are we doing an evaluation of these teams that have gone out? There is varied success, and it is obvious that some members of the team have not taken the courses.

ORGANIZATIONAL UPDATES

BIA (Kenny): PL 4, very active fire season, many fire prevention, and investigators out.

BLM (Jon): Increased funding for more mitigation. Guide produced on how to prevent, mitigate and prepare for wildfires. Down to "only" 4 state leads. Trying to rewrite CFR on how to deal with fire trespass laws. Working with FWS on an electronic file-sharing trespass case system.

FWS (Terri): Not in attendance.

IAFC (Bruce): Tom Boggus, State Forester retired end of May. IAFC WUI conference is November 14-16 in Reno.

NASF (Fred and Angie): Western states fire managers annual meeting (virtual) was held. Earlier and longer fire season noted in the western states. Wildfire Division Manager is retiring from Washington and recruitment is out, closes on July 6. Personnel changes going on in Alaska as well. Fred was not in attendance.

NIFC External Affairs (Carrie): Want to share information on what causes fires rather than just how to prevent them. Edits for the prevention page are welcome and can be submitted. Some of the content for PIOs is moving from the NIFC site to the Teams group for PIOs.

NOAA (Doug): Not in attendance.

NPS (Tina): On leave. Gwen served as Chair for meeting.

USDA FS (Gwen): Our Chief at the Forest Service, Vicki Christiansen, has announced her retirement as of August 2021. We will miss her. She has always been very supportive of wildfire prevention.

Acting Fire Director, Patti Grantham, has retired and the new acting is Bill Avey, Forest Supervisor on the Helena National Forest in MT.

We've had a difficult start to the fire season, with a helicopter crash and the death of 4 contract partners, an off-duty death on a prescribed fire assignment, the death of a jumper, and a hot shot crew quarantined while traveling to an assignment due to a COVID-19 exposure.

Outdoor Fire Safety Brochure is VERY close. Gwen thinks they will be going to printing soon and they will be available at the Symbols Cache. She will definitely keep the committee posted.
