#### **COMMITTEE BUSINESS:**

- Chair's update Tina: IAFC is trying to find a replacement for Bruce for this committee.
- <u>NWCG Coordinator remarks and news and update Sarah:</u> Got \$22.5 million of BIL funding for systems improvement over next 5 years. Will analyze positions in 310-1 to ensure not over-training. Hoping to award a contract for this, possibly in May. CEPC committee will be involved.
- <u>Fire Prevention Education Team Subcommittee update Maureen:</u> Subcommittee's meeting is next week. 12 or 13 teams have gone out this season. The subcommittee will discuss possibly working on getting Team Leader Guide updated and out.
  - There are two eclipses coming up: Oct. 23 and April 24. An Interagency group is working to develop messaging on this, especially for social media. Artwork is also under development by USFS conservation education staff, and the symbols cache will likely have some products to hand out to the public (with USFS support). The ad council is working on concepts/memes in English and Spanish. When final, all messaging, artwork, etc. will be available in toolbox on smokeybear.com.
- <u>Wildland Fire Investigation Subcommittee update Carrie:</u> The subcommittee is still planning an in person meeting/training Oct. 24-28 in south Lake Tahoe. The group is gathering investigation photos for the training.
- <u>PIO Subcommittee update:</u> (update given by Tina, who was briefed by Candy). Chris provided IMRR group with pieces for evaluators to aim towards for PIOs to go from PIO-2 to complex.
- <u>Fire Restrictions Task Team Kenny:</u> Team has a meeting tomorrow. Maureen has looked into OMB approval process for the survey on how the different GACCs are posting data on

restrictions/alerts, etc. (the process would be 6 months +). Another other option would be to have a non-federal partner that could do it with their own money. Maureen reached out to NASF (Whitney Foreman-Cook), and they said they could do it. But first, Keith Smith (IT manager for NASF) should be brought into the mix. Maureen can meet with Whitney and Keith to discuss further. Jon asked whether there are any plans to create a fire restrictions app in the future? Nothing firm has been discussed on this as of now (it wasn't part of the current tasking and would require a separate budget request). Google has shown interest in pulling together this type of data, based on geolocation; that would require lots of work on keeping data updated.
