COMMITTEE BUSINESS:

- <u>Chair's update Tina:</u> Introduced new International Association of Fire Chiefs (IAFC) representative Jodie Barram; reminder to get budget requests in by end of year.
- <u>NWCG Coordinator remarks and news and update Sarah:</u> Sarah is working on the CEPC website updates (will take effect in January). New NWCG position (Systems Improvement Project Manager) has been announced is currently open; let Sarah know if you have any questions or know someone who might be interested.
- <u>Fire Prevention Education Team Subcommittee update Maureen:</u> The FPET SC held an after action meeting for Team Leads on 11/17 (they confirmed the expectation is that team leads should be on site). There were 19 team assignments in 2022. The schedule for 2023 is now being developed. The FPETSC meets on 12/15 and will be finalizing the 2023 Program Plan, the FPET Team Leaders Guide, and the FPET Host Unit Guide. Preparing submission for the 2023 Mobilization Guide. P-310 training is taking place in Tennessee (hosted by the State of TN); Maureen emailed out info on this people can still sign up by contacting Robin, even though the class shows as closed on the site.
- Wildland Fire Investigation Subcommittee update Shawn: Shawn is now chair and Scott Fisher, BLM, is vice-chair. Subcommittee is still working on updating FI-110 and 310 as well as updating PMS-412 Guidebook (this is nearing its initial review). Once complete, subcommittee will move on to updating 210 coursework. Updating PMS-412 again will be longer term future project will be updated to more of a manual along with a pocket guide for field use.

Communication, Education, and Prevention Committee (CEPC)

- <u>PIO Subcommittee update Chris:</u> PIO Subcommittee is working via email on budget items; won't be meeting in December. PIO-3 was approved (memo has come out on this). Hearing positive feedback about the PIO-T implementation this year. Upcoming priorities for 2023: will be looking at S-203/pulling out info for 103; looking at position-specific trainings related to CIMT etc.
- <u>Fire Restrictions Task Team Kenny:</u> Fire restrictions survey was released; as of 12/8/22 already about 120 survey responses! Closing date is January 6th (if needed can be sent out again; but that likely won't be necessary based on great response so far). Working on data standards with the Geospatial subcommittee. Looking at fire restrictions data standards possibly going out Dec. 30 for a 30-day review. Team will meet again Jan. 19th to go over survey results and will summarize responses. Putting together a funding proposal to bring in a business administrator to help with restrictions site.

Regarding training, under Learning Portal, added that we're not limited to online or in person (such as hybrid, pods, etc.). Dates for updating the plan were edited; related to needed course updates. Costs: these were discussed; these depend on whether contractors hired or not, and many other things, so an estimated cost range is needed.

- 2023 F2F Meeting (Kent): In October, we discussed having the face-to-face meeting in Maine next year. There are facilities available the week of October 9-13 at the Schoodic Institute at Acadia National Park. 1.5 hours away from Bangor airport. The conference room holds 10-15 people (and has video conferencing capability), and there is cabin-style lodging. Each cabin holds about 3 people, and meals are provided. Rates should be under our per diem rate, though Kent doesn't yet have exact rates. We probably need to get a contract signed within a few weeks, to make sure the space is held (they're currently holding 6 cabins for us). Kent will check on their cancellation policy. Sarah will look into whether there are any NWCG restrictions on this type of meeting, but likely the only issue to be aware of is that agencies must pay for travel. Action Item: CEPC will discuss this again after the holidays.
- <u>Budget requests</u> (Tina): Window is open now (through last week of January) to submit 2024 budget requests; NWCG will review these starting in late January.
- Planning for geographic area call (Tina): Tina set up a call for Feb. 15th 2023; invite has been sent out.
- DoD participation needed on CEPC? (Tina): Per Sarah, as they come on board, they could give us names of who they'd like to add. CEPC can also follow up in the future.
- Follow-ups from 2022 F2F meeting: Historic documents: Maureen compared what she has to Pat McDowell's documents (BIA) – this is complete. Look into NWCG doing a link to capture comments after each training course (as an evaluation), plus periodic post-assessments: this is in the works.
