COMMITTEE BUSINESS:

- <u>Chair's update Tina:</u> We'll table discussion about tasking for the P Courses a smaller group will have a call on this tomorrow. Tina was invited to speak at the Southern Wildfire Prevention Learning Exchange Webinar (see email from Tina to CEPC on 4/13/23) others can participate too, if they would like.
- <u>NWCG Coordinator remarks and news and update Sarah:</u> Provided an update on the progress of Incident Performance & Training Modernization (IPTM) effort, and status of FY2024 project funding requests for CEPC. Tim Blake (one of three NWCG Coordinators) took a new position with BLM as a Safety Manager. NWCG is working on announcing a detailer soon, but until they start Sarah is trying to cover Emergency Medical Committee, Equipment & Technology Committee, Incident Business Committee and their subgroups. (Katy O'Hara is covering National Interagency Aviation Committee, Risk Management Committee, and their subgroups).
- <u>PIO Subcommittee update Chris:</u> The subcommittee's next call will be in a couple weeks. They have been working on an updated graphic on positions and pathways which they're hoping to finalize and post to the website soon. They'll be making decisions on where to head forward with training now that budget info has been received. They're working on some documents that show the differences between different taskbooks this will be a big undertaking but should clear up nebulous information.

- <u>Fire Prevention Education Team Subcommittee update Maureen:</u> (Sarah provided update): FPETSC is meeting next week. The Chair is transitioning to Mark Thibadeau (from Zach Ellinger), and their publications (Standards and Host Unit Guide) are going to the Executive Board for the 1 month review next week and then will be on the agenda for approval at the May meeting. We do not foresee any issues with their approval.
- Wildland Fire Investigation Subcommittee update Shawn: (Carrie provided update): The subcommittee has been working on FI-210. They haven't had a meeting recently but will meet in May. Sarah met with Shawn and others at EMI EMI is interested in putting on FI-210 and will shadow a course in California.
- <u>Fire Restrictions Task Team Kenny:</u> The task team is in a holding pattern; Kenny will do a final writeup to closeout. Katy O'Hara will be working on proposals for WFIT funding and will reach out directly to the task team.
- <u>Training Task Team Angie:</u> See document Angie emailed to CEPC, 4/13/23. **CEPC will discuss this** on the next call and decide whether the document Angie emailed 4/13/23 can be posted. Action Item: all CEPC members review this document and be ready to vote next month.
- <u>WPSAPS:</u> Tina reached out to find out where we are with WPSAPS still has not heard anything. CEPC is listed as NWCG steward for WPSAPS. Sarah will check with Katy O'Hara on this.

DISCUSSION TOPICS

Topic

- Update about prevention coursework in the Wildland Fire Learning Portal Fred Turck: P-101: Fred made a proposal/talked to NWCG training staff, about developing an optimized P-101 for the portal (32 hours), with a very basic P-101 (2-4 hours) then a P-101 with more specifics (might be 16-24 hours, which would be the meat of the course) and a P-301 for next level. Fred has been working on revising P-101 since before he retired, along with several other people and financial support from the Portal, to help create a new course. The new course was delivered for the first time last week (in MT). Over 90 students signed up. It was a blended course, in the Portal (4 instructors + facilitator). Each unit has been recorded and is self-paced. Second course delivered this week to almost 70 people. The plan now is to take evaluations/comments and clean up the course, package it up and put it in the Portal Sharing Library, with an instructional document, hopefully within the next couple weeks. It will be a revised P-101; more of a blended, mostly self-paced option that meets NWCG requirements.
 - <u>WPSAPS:</u> Fred came on board through USFS ACES program is a contractor, working for Maureen. USFS is planning on 4 course deliveries for WPSAFPS this year across the country. BIA has been the leader in WPSAPS. A course is scheduled for April 25-27, all virtual, for 50 people. Several other courses are scheduled for this year too. Schedule is posted online There's a revised agenda, and a solid program in the Portal to deliver WPSAPS moving forward. The challenge is finding enough instructors. Currently, there are only a few with enough comfort to deliver the material hopefully we'll be able to build more capacity in the near future. The student and instructor guides have been updated to match the changes in the software.
- Discussion about committee technical support All: See Sarah's email from 4/12/23. Some other

options for support: NWCG has been talking about career development options for some entry-level employees for NIC staff. Sarah has four people who are looking to provide some support to the committees (all NWCG committees are options). One in particular is interested in CEPC. Can help with notes, organizing agendas, whatever CEPC needs support with. Tina and Caron will discuss this further then Tina will circle back with Sarah.

- Revisit options for face-to-face meeting All: During Feb. 15th call with GAACs, Alaska was interested in hosting (in Fairbanks). North Carolina and Colorado (Boulder/Broomfield) were also suggested. Solidifying a location would be good so Tina can start looking at logistics. From cost standpoint, CO makes sense (more central). Might look at AK for 2025 (their interpretive sight for Haystack Fire would be ready by then). CEPC voted and agreed to Colorado (Boulder area) for October 2023. Action Item: Tina will connect with the GAAC member who put forward the suggestion and begin working with them on meeting logistics.
- <u>Fire Causes</u> have not yet heard anything.
