### **COMMITTEE BUSINESS:**

- <u>Chair's update Carrie:</u> Carrie is now chair of CEPC. Tina is on a 120-day detail but will return to CEPC (as a member) after her detail. Several CEPC members are out on fires, etc. Planning for our inperson meeting: It will be held the week of October 16<sup>th</sup> 20<sup>th</sup> (meet Tues-Thursday of that week and travel Monday/Friday). Tina was working with Brant Porter, NPS on some logistics. Carrie talked to Brant today and there is a possible meeting place in Ft. Collins. Could visit sites of Cameron Peak fire, Marshall Fire, and could meet with Mike Smith, IC for Marshall Fire to give us a tour of the Marshall Fire area. Mike Chard from Boulder County office of Disaster Management also might be able to meet with us (he was on the Marshall Fire). If anyone has specific thoughts, feel free to send them to Carrie; we can start working on an agenda for that meeting. The NPS office in Ft. Collins has hotels nearby.
  - o Kent was also on the Cameron Peak fire. Tours of these fire sites could help show us about unusual fire situations, and what CEPC can do related to this in regard to messaging, etc.; also info on the fire investigations could be useful.
  - o FEMA recently released a report on the Marshall Fire (Faith emailed to Carrie to send to CEPC for background).
  - o Chris Barth knows some people in the area and can help if needed as far as lining people up to meet with.

- NWCG Coordinator remarks and news and update Sarah: Not on call but sent notes to Carrie:
  - o Hiring has been a big emphasis due to the number of vacancies over the last 2 years. This month hired 4 new Training Specialists, 1 USFS A/V Specialist, Deputy Program Manager cert issued and with SME panel, Coordinator interviews occurring, 2 BLM and 2 USFS Writer/Editor Detailers selected, Instructional Systems Specialist announcement is out, and selection being made on the Communications Manager.
  - o In July the EB confirmed that the use of the Field Evaluation is only for CIM positions and not T1 C&G, they worked on criteria for agencies requesting NWCG membership, and how to engage under-utilized partners. Next week for their monthly meeting they are deciding on the Prescribed Fire Practitioner Alternative Pathways proposal, discussing RMC's progress on a potential WFF fatigue study, determining the EB intent for the 2024 NWCG Annual Meeting, and approving the criteria for agency/organization membership in NWCG.
  - o For the Incident Performance & Training Modernization (IPTM) effort, for the new 'big' contract this year HECM, SOFF, PTRC, EQTR, and SCKN are all under way. This fall working on FELB, FIRB, ENGB, ICT5, and FFT1; and we are in the process of determining and scheduling out 2024 incident positions.
- <u>PIO Subcommittee update Chris:</u> the PIOSC put a memo together talking about Inciweb/Drupal challenges; a group met with USFS managers for Inciweb/Drupal and are working on making some adjustments. There was a suggestion to develop a long-term Inciweb steering committee not yet sure of the exact scope of what it will look like, but it is in the works. There are opportunities to think ahead about what kind of systems could exist; more automation, etc. PIOSC responded to IWDG tasking regarding standardization for individual surge team capacity at the complex level or Type 3 setting; response was submitted and now waiting on comments. PIO Toolbox in Teams now has a separate channel for Inciweb discussions.
- <u>Fire Prevention Education Team Subcommittee update Mark/Maureen:</u> Update provided by Zach Ellinger. New FPET chairperson: Mark Thibideau; co-chair is Stacy Grimes; Nick (NICC dispatcher) is helping with notes. Next upcoming training P-310 (Fire Prev/Education team member training) will be in January on Angeles National Forest 1/22-1/26. NWCG recently published two guides: PMS464 and PMS474-O (Host Unit and Team Leader guides). 4 FPET teams have gone out so far this year: First was to SW area, then teams to NM, ID, and TX. Nothing additional on the radar as of now. Good reviews of the teams who have gone out so far.
- <u>Wildland Fire Investigation Subcommittee update Shawn:</u> Working to get PMS-412 out for technical review (possibly will go out sometime next week, with review due October 15th). The collaborative FI-210 (Wildland Fire Investigation) course has been finalized. Students will be flown to Redding, CA to the USFS/Cal Fire joint compound (September). There has been some international interest in the class.
