#### **TUESDAY, October 17**

### Expectations for this meeting/where we hope to get out of this week:

P101 – status? Other trainings we need to look at?

Discuss joining with WUI committee/other committees – put together a joint meeting/conference in the next couple of years (like previous wildfire prevention and mitigation conferences)? Also maybe build upon the meeting we had earlier this year with other geographic area prevent/education committees. It's important to connect with others and discuss the cutting-edge research. Canada would be a good partner to invite. CEPC would have more of a coordination role if we did a large meeting/conference; would present on what we do. Jon can begin looking into how we could support a meeting like this.

### **CEPC Subcommittee Updates - PIOSC, FPETC, WFISC, & Training**

<u>PIOSC (Chris Barth)</u>: PIOSC has a lot going on; having regular monthly meetings. There will also be additional work sessions beginning in December to work on specific items such as training (working in conjunction with IPTM modernization) training for S-203/aligning with PIO-3; something along the lines of a 103 course to go along with PIO-T. In discussions about whether to bring 403 back. Another work session will be about branch

lead positions (do we formalize this or incorporate some other way?). L23-02 will have some follow-up taskings. Looking at standard configuration for information in CIMT world.

A long-term action item is to help to facilitate a national PIO/IMT meeting. (CIM, IMT-1, IMT-2 and IMT-3) – see how PIOSC can help to support these PIOs.

<u>Inciweb working group:</u> PIOSC sent a memo through NWCG to Inciweb/Drupal development team and got good response from USFS to resolve issues. PIOSC had proposed a long-term solution of developing an Inciweb oversight/working group, to get perspective from the field to the development team. The chatter from IMRR needed to be diverted to a different Team people have access to (now through the PIO Toolbox), so the Inciweb/Drupal team can see what the issues are, and issues are documented. WatchGroup is another system – PIOSC would potentially like to see its data incorporated into Inciweb. PIOSC asked CEPC about whether there's a need to formalize this Inciweb working group? PIOSC's recommendation is to continue this as an advisory/working group for now; do AAR from this year; then come back to PIOSC in a year or so to see if more formalization is needed. CEPC discussed this and was good with that plan.

PIOSC is still looking to find a USFWS rep.

PIOSC is looking forward to hearing more from NWCG on first phase of IPTM; what new requirements will be; this may impact next year's budget request.

Chris Barth is starting detail with Rocky Mountain Research Station starting in November, for 120 days (through end of February).

<u>Fire Investigation Subcommittee:</u> Will be meeting next week in Chico, CA (36 members). They have reps from all agencies including CalFire and international groups, and some who represent insurance. They have a few projects out for peer review: PMS-412 (Wildland fire origin and cause determination guide); the first revised FI-210 class through NFA was taught a couple weeks ago in Redding as a collaboration (this was a beta-test for the new revision) – after getting feedback they will do any needed updates and then finalize. FI-110 should be available soon - NWCG training coordinator is working to get it onto the portal.

<u>Fire Prevention/Education Team Subcommittee:</u> They've had 7 assignments this year (about half the average, due to quieter fire season). All the hosts asked for there to be 11 – 16 personnel on FPET teams. Working on agendas for one-hour trainings for team leaders, members, and PIOs. Doing quarterly meetings, currently more geared towards training.

### **Agency Updates**

**BLM** – Community Assistance program provides money and expertise for partners; wrote a strategic guide for this, discussing what is important to BLM in engaging with communities. The Wildfire Research Center (WiRē) program has a proven way to go out and help communities – BLM funded a mitigation specialist position with them. Also hoping to reach out to disadvantaged groups to find those who might be more severely impacted by wildfire/climate change and reach these groups.

Planning to put on a National Fire Education campaign next year from BLM; hopefully to launch next summer – will include info on rangelands, etc. (first BLM is doing a survey of fire staff to learn where to further focus the campaign).

Power company issues have been a big topic for BLM. The budget passed in 2018 covered expedited treatments around rights of way (ROWs); BLM is just getting a rule out; info is being put into ROW agreements.

BLM is updating their Prevention Handbook/Manual.

BLM will be holding a Fire Investigations meeting April 22-26 in Reno.

**USFS** – Finished the PD for Prevention Specialist (likely GS-7) – it's with HR now.

Community of Practice SharePoint site is up and open to everyone now. USFS started doing webinars for the Community of Practice for Prevention and Mitigation (will be every Friday). Community of Practice page has a tab where strategic plans for both prevention and mitigation will be posted soon.

Last week was Smokey's birthday, 80<sup>th</sup> coming up; big campaign and activities planned. Will be working on WPSAPs and more. Two new PSAs are out for tow chains and campfires.

Cohesive Strategy draft report came in, will be reviewed, and report out to group soon.

**NASF** – **Eastern:** Had a hot air balloon up from NM for Smokey's 75<sup>th</sup> birthday, which was a very successful prevention event; trying to do that again for the 80<sup>th</sup>. Reached out to other partners/states to help share the cost and hopefully have a joint prevention event.

Sent crews up to Canada this summer and got lots of smoke in the U.S. northeast from Canada's fires. Lots of interesting PIO calls related to this!

New Chief Forest Ranger has made changes in open burning laws which go into effect Oct. 25<sup>th</sup> – lots of outreach associated with this (brochures, etc.).

**NASF** – **Western:** nothing to report.

**BIA** – Just revised Investigation Handbook as well IDIM-6 manual.

Working on coordinating a National Prevention meeting for BIA (possibly Phoenix in March) – not sure yet whether this will be opened to other agencies, or just BIA/tribes.

Working on WPSAPS continuously; testing software and upgrades and keeping student/instructor guides in sync as changes are made.

At the National level, BIA is talking of creating a new position: National Prevention Program and RTRL Coordinator (Reserve Treaty Right Lands). All regional Prevention Specialist positions are filled.

**NPS** – Tina will be finished her detail at the end of November. In the process of hiring a Visual Information Specialist for the FPMC in Boise. Have had a VIS detailer who has helped make NPS-branded prevention graphics.

### WPSAPS - What's new and what's planned for 2024 (Sam Scranton, BIA)

Wildfire Prevention Spatial Assessment and Planning Strategies update.

Business committee has reps from FS, BLM, BIA, FWS, NPS, and NASF with monthly conference calls; they discuss work plan, and 5-year work plan.

New agreement in place: POP Oct. 1 to Sept. 30. FS and DOI funding. DOI FY23 funding off the top; FOI FY24 funding planned from OWF.

Application available for all users (requires EGP account; must request WPSAPs access from EGP).

Testing of enhancements & new functions are ongoing – always looking for people willing to test. No trainings are currently scheduled. January is a tentative time.

#### Fire Restrictions Task Team – Quick update & Next Steps (Kenny Jaramillo)

Original tasking was to identify a suitable platform, what fields/spatial elements, etc. needed plus timeline and funding needs.

Formed a committee of 6 members; looked into the various platforms already in use across the country, most use AGOL. Came up with survey asking about interest, how restrictions are being used, etc. Survey closed in January 2023, with a big response. Info was compiled – found there is interest, some skepticism about use of funds; restrictions in some areas are based off elevations. The geospatial data standard was approved. Committee found that the definition of restrictions could be updated (in NWCG glossary).

While doing the survey, the committee also submitted a funding request to contract out for building/maintaining a site with a 5-year plan. Would be a hub site and pulling in existing AGOL sites. NWCG liked the proposal but felt it would fall better under WFIT funding, rather than CEPC. Kenny is still waiting to hear back on whether this will move forward, or whether there is a need for an additional request. Kenny asked Sarah Lee about this at this meeting, and she will follow-up with Katy, and will also forward a Business Needs form to be filled out. Data management/timeliness would be big issues for a potential site. Tracking statistics over time could be useful. [Form sent to Kenny and Carrie to fill out].

<u>Next steps</u>: Finding out about funding under WFIT (Sarah may know more info); look into getting a contractor. Down the road, discuss whether this task team needs to be a formal subcommittee, and if so, where they would fall (IT more so than CEPC?). Who would be COR for a contractor?

### Fire Cause Update (Jon Skinner)

\*Jon shared a document\*

New fire causes have been out about a year. General cause categories include Natural, Undetermined, Human (with many sub/specific categories).

People had put fires in the Undetermined category without going back and updating them. This really affects the data. Undetermined fires should be further explained as to why they are undetermined.

Currently, several subcommittees such as data mgmt., fire investigation, etc. are working together to reach out to all the agencies to see: 1) is the current fire cause reporting working for them; and 2) Do we need to write a user guide for these causes?

<u>Action Item</u>: It might be useful to do a survey to other states to find out what they're using; what's useful to them. Angie can informally ask Eastern states and can help Jon on this project. [Involve the WFISC with the task group/team – task team memo?].

### Fire Danger video review for Fire Danger SC – comments

CEPC watched and discussed the video as a group; CEPC members will submit comments via the requested form individually.

Some comments discussed include:

- Seems like this could be used to educate the general public (not just new staff)
- Fire danger is also a predictor of fire ignitions; not just likelihood to spread (this isn't accurately represented in the video).

- Temp, humidity, and wind are only factors listed. Should it get more into large diameter/small diameter, fuel moisture, other factors? Maybe mention the NFDRS?
- Remove a little bit of the discussion about moving resources.
- Smokey artwork wouldn't be approved has to be on hat and buckle USFS would need to approve use of Smokey.

### Wednesday, October 18 - Field Day

### Trip to Boulder for Marshall Fire presentation and field tour.

- Office of Emergency Management, Boulder County Disaster Management Director Mike Chard, Boulder County Sheriff's Office Communications Director Steve Silbermann, Mountain View Fire Rescue Deputy Chief Sterling Folden, Disaster Management Coordinator's Shannon McVaney and Monika Weber (Mitigation Specialist), and Boulder County Sheriff's Office Deputy Randy Wilber. <a href="https://boulderodm.gov/about-odm/">https://boulderodm.gov/about-odm/</a>
  - Check out the FLA on the Marshall Fire.
  - Responded to two other wildfires north of Boulder a couple hours prior to Marshall initially called in as a downed powerline (no fire reported).
  - Lessons engage the community, be transparent, critically assess actions, complete AAR and improvement planning (follow through); be prompt, be honest, and solve the problems you can.
     Are our first responders prepared? Challenge your assumptions.
  - Crisis communication empathy, facts, and hope. LISTEN!
  - Consequence management 0.1 % of incidents it is OK to deviate from ICS doctrine into a "mission command" situation calls for independent action(s) return to ICS, check in when time is right.
  - o Addressing chaos assess the impacts, manage needs and initial capability, reflex time.
  - Have an evacuation plan, but also plan for re-entry. Need to prepare people for fire recovery and debris management. May look at building into CWPPs.
  - Delegation of Authority should be referred to as a delegation of responsibility.
  - Need better education on alerts and systems for alerts.
- Brant Porter, NPS, field guide (Mike Smith initial IC of Marshall Fire was dispatched to a fire).
  - Fire origin and possible multiple ignitions.
  - Set the scene fuel loading and weather conditions; December 30<sup>th</sup>, people on vacation.
  - Look at escape routes and safety zones (Costco evacuation seems like it would be a good place for shelter in place - roof was on fire).

### NWCG Coordinator Remarks and Update (Sarah Lee) - 0900

Sarah recently accepted the Deputy Program manager position at NWCG. Katy O'Hara will be our new NWCG coordinator starting in November.

NWCG had been at 50% vacancy; now the only vacancies are audio-visual lead and a couple positions under that – they are very close to being 100% staffed.

Call for budget requests (FY25) will come out in November, and are due at the end of January.

Web transition for NWCG going on in November (2-17) (working on searchable digital library); once it's back up, can load anything that isn't digital.

Fire Restrictions website proposal – under WFIT? Sarah will pass this along to Katy O'Hara to follow-up, and will send the "Business Needs Form" to be filled out.

Action Item: P-101 is good to go; Carrie to follow up with Rick Gividen, NWCG Wildland Fire Portal Governance Board.

### Smokey Bear 80<sup>th</sup> Birthday Committee Update (Mandy Scott)

- Accepted into Tournament of Roses Parade on Jan. 1<sup>st</sup> (region 5 is handling that). The Chief and R5 Forester will be on the wagon. Angie will represent one of the state forester positions. Will have same wagon with mule train as before. Will also have a booth for fire prevention info.
- National Garden Club has Smokey/Woodsey poster contest is on their website and on SmokeyBear.com.
- Smokey Bear reading challenge pilot with Georgia Public Libraries will later go national. Targeting public schools and public library including military and Tribal libraries.
- Smokey Bear Live 4 broadcast planning meetings began this month for upcoming topics.
- CA State Fair will do a broadcast from there.
- Smokey's Birthday event will be in DC on the 9<sup>th</sup> will present Smokey Awards and poster contest awards. Will also be in the Macy's Day parade.
- Putting together a toolkit which will be available on the website by end of December.
- NASF is also putting a link on their website where people can add their events.
- Cache products will be available end of Nov/early December.

<u>Wildfire Research (WiRē)</u> – overview of program and research in Grand Co affected by the East Troublesome Fire. James Meldrum, Research Economist, USGS - presentation in CEPC Teams folder. Group has been working together around a decade on the interface between wildfire mitigation and education programs – work with local communities.

Actionable social science to support evidence-based education programs. Building data set to look at how people think about risk. Mitigation on private land and preparedness of community residents are essential. All projects have either local, regional, or state partner involved. Scales of projects are a few hundred to a few thousand homes – very localized/small-scale.

Two pieces to the approach:

- Rapid wildfire risk assessment by professionals (Home ignition potential, Background conditions, Defensible space, Access).
- Social surveys of residents in the study area.

A goal is to link homeowners to local partners.

#### Insights

- Perspective matters when discussing risk.
- Residents prefer local and more detailed media sources. Local fire department is often top information source.
- Personalized information influences response to outreach.
