- <u>NWCG Coordinator remarks and news and update Katy:</u> Website transition has happened (last week). There are still some lingering issues with content transitioning; some may resolve in the next few days. Next week, if there are still any gaps/missing info or broken links, send those to Katy. PIO SMEs will be in Boise in next couple weeks.
- <u>PIO Subcommittee update Chris:</u> PIOSC will be transitioning Chair roles in May, Kari Greene will become Chair. Have been going through website updates and keeping list of issues. SMEs for Incident Performance and Training Modernization (IPTM) had a few last minute changes, but have 8 SMEs plus one PIOSC member participating. PIOSC discussed NWCG looking at SOPs subcommittee is on track with outlining some more specificity in PIOSC's SOPs. PIOSC is in a good place, and moving ahead is looking forward for being prepared for PIOC to go through IPTM, and looking at evaluation/auditing.
- <u>Fire Prevention Education Team Subcommittee update Mark:</u> Trying to get a few things going from ground level: Region 5 prevention committee has put a Prevention Academy on their program of work

as an interagency effort (will hopefully be a national offering). **Request SMEs from CEPC members for each agency to review and agenda when developed**. Briefing paper submitted to Carrie on suppression vs. prevention staff/staff needs on training, etc. (Carrie emailed to CEPC members). Interested in 2025 selected positions for IFPTM; would like to get SMEs together. Anna Henderson at Washington Office is working on PD rewrites and looking at Prevention PDs. PREV qual – looking to put in some typing. PETM/PETL – wondering how we update positive training requirement of P-101 for both team member and team leader? Per Katy – that is an IPSC process; would go in through a Request for Change process; Katy can go over this process on a future call, and one-on-one with Mark in the meantime. P-301 and P-101 aren't required but are outdated – will be looking at getting the ball rolling on updating these. NWCG process – subcommittee will have to start this process; Katy can share course templates; while going through IPTM, NWCG won't be able to assign training specialist or writer/editor etc. immediately since they're not required trainings. **CEPC agreed as a group that they support the FPET subcommittee pursing:** 

- 1. Change proposal to look at positive training requirements for P-101 to PETM, and P-301 training requirement for PETL.
- 2. A request for change pursuit for typing prevention officers.
- <u>Wildland Fire Investigation Subcommittee update Shawn:</u> No new updates. Work continues on various ongoing projects. There has been some headway with the authors on one of the studies on FPET indicators; they are willing to share data and have more in-depth conversations.
- <u>Fire cause task group update</u> This group was reinstated due to issues with reporting in INFORM system causing an increase in undetermined causes. It's a robust group, which has expanded to include dispatch representation and others and is meeting every other week. The group had their first meeting last week to divide up and assign tasks, work through business rules, and more. Kenny/Jon can report out on this group on future CEPC calls.
