## **COMMITTEE BUSINESS:**

- <u>Chair's update Angie:</u> Participating in subcommittee meetings/NWCG meetings as invited. Lots of good work going on.
- NWCG Coordinator remarks and news and update Sarah Lee: Katy is gone (took the deferred resignation). Sarah will be our interim coordinator. NWCG will have only 33% of usual number of coordinators by the end of next week; 20% publication staff, and 50% of training staff. NWCG is working through the process for hiring and bringing in detailers as the highest priority, and will be prioritizing mission-related workload. Reach out to Sarah with any needs/questions.
  PIO Subcommittee update Kerry Greene: SMEs having been working on S-203: the course was to:

<u>PIO Subcommittee update – Kerry Greene:</u> SMEs having been working on S-203; the course was too long, and they're now working on shortening it to 30 hours or less of instruction. SMEs are in 7-day review period; the goal is to get it ready in time for upcoming fire season.

Some content could be stand-alone online training (OLT) to be taken before coming to the classroom portion; this would be for universal content, such as checking into an incident, etc. The OLT portion

would be approximately 1.5 hours. Because of the change of modality of training, approval is needed from CEPC (via a vote); and vetted through agencies.

\*\*CEPC voted on changing modality of training: Decision: **CEPC approves the modality change to S-203 from ILT to blended (OLT 1.5 and ILT 28 hours).** (*ILT - Instructor-Led Training, and OLT - Online Training)* Sarah will work with Kerry regarding next steps.

- <u>Fire Prevention Education Team Subcommittee update –Mark:</u> This will tentatively be Mark's last CEPC meeting, as a new co-chair has been selected (Jeffrey Moyer, BIA). Chair is Stacey Grimes. A webinar was held for team members and PIOs on Feb. 27, and was a great success. The subcommittee recently went over regional feedback; discussed use of Firenet (not using Google). They're in the process of looking at the Digital Library; will need to coordinate with NWCG for an update. Lots of interest in AD hiring in Prevention/Education teams waiting to hear on whether this can be done.
- Wildland Fire Investigation Subcommittee update Shawn: PMS-412 is back from editor; getting close to finishing. FI-210 will follow next and is mostly done; at the in-person meeting the week of April 20, the subcommittee will will try to finalize FI-210, then will route for review. Shawn has been involved in and will Chair the first International Wildfire Ignition Conference (WIC), in Portugal. A WIC website has gone live, and they'll be accepting submissions soon. The conference might be in Colorado next year. There could be issues with travel this year. A questionnaire will be developed to go to international fire investigators to see what issues exist worldwide, with the goal of bringing those in this discipline together. Shawn has been working on getting an article on Fire Pattern Indicators published through IAWF it will be published in their next edition, and the intent is to stimulate interest in research.
- <u>Fire cause task group update Kenny:</u> Not on call. Per Angie Fire Cause task group met on March 6, and are continuing working on cause categories.

#### **DISCUSSION TOPICS**

- 1) Accomplishment and Action Tracker Angie. Angie put together a spreadsheet which she shared during the meeting, to track comments from the Strategic Plan which were Action Items, including a list CEPC can start working on for 2025-2027. CEPC members should review the spreadsheet and compare it to comments in Strategic Plan to make sure nothing is missed. In subsequent meetings, CEPC can discuss Action Items from the spreadsheet, begin assigning Goals and Timelines.
- 2) In-Person Annual Meeting Southwest has been brought up as a possible location maybe in Albuquerque/Flagstaff/Phoenix/Tuscon? Per Tina Saguaro National Park in Tuscon has a fire-prone ecosystem and could be a potential spot to visit. Anyone with ideas for location, send to Angie and she will create a Doodle Poll to see CEPC's preference.

Gearing up for spring wildfire preparedness events, in prep for a busy year.

Fire Prev/Ed Teams – struggling to find instructors for P-410; if anyone knows of instructors, let Mandy know. AD hiring is a concern – lots of team leads in Prevention are ADs. Working on revamping SmokyBear.com – great changes happening, and Mandy will share when complete.
