COMMITTEE BUSINESS:

- Chair's update Angie:
 - Kent attended the NWCG Connections call for Angie. On the call, Erica Lamb discussed how publications will prioritize IPTM; timelines will be extended due to staffing. Steve Gaskill discussed RT-130 which has 8 new modules and a storymap, with lots of views on YouTube. The Leadership Committee discussed L-280 and Lead by Example Awards. Sarah Lee discussed the WUI Mitigation Field Guide (available electronically) Sarah has the latest proof.
- <u>NWCG Coordinator remarks and news and update Sarah:</u> Erica Lamb lateralled in from publications manager to a coordinator. NWCG has lateralled in a new publications manager from BLM AZ. NWCG has submitted a request to hire the vacancy behind Katy O'Hara (456 position).

Communication, Education, and Prevention Committee (CEPC)

- <u>PIO Subcommittee update Catherine Koele:</u> Accomplishment tracking is done and will be put forward soon. The PIOSC updated social media Best Management Practices, which will be re-posted soon on NIFC. Regarding the approval for change of modality for S-203 PIOSC had checked in with NWCG, and will use NIFC EA-created video for the online portion NWCG does not need to vet. Kerry has found a potential alpha group to test when ready. (Angie asked about observing the alpha portion, which can be done with permission from the instructors). 310-1 changes: Beginning in 2026, one will no longer need to be qualified as PIOT before becoming a PIO3. The "What Kind of PIO am I" graphic has been updated and posted to committee page, but will be changed again with 310-1 change. IMRRs are on pause; PIOSC will be meeting with PIO leads to engage on changes during the pause.
- Fire Prevention Education Team Subcommittee update Stacey: Not on call.
- <u>Wildland Fire Investigation Subcommittee update Shawn:</u> Shawn not on call. Sarah gave update: The subcommittee will have an in-person meeting the week of April 21, in Denver. During this meeting, they'll do revisions to FI-210. The subcommittee has sent a draft Scope of Work for an X-902 course update to OLT. PMS-412, Investigation Standards, is out electronically; just waiting on published versions for the cache. FI-310 course is done as far as professionalizing videos. For FI-110, final signatures were obtained this morning.
- <u>Fire cause task group update Kenny:</u> The task group hasn't met in a while but has a meeting scheduled for next week. No additional updates since last call.

DISCUSSION TOPICS

- 1) Operating Plan Review Angie. VP discussion (see below). CEPC removed NIFC EA from the Chair/Vice Chair rotation as they are not primary members. All CEPC members should look at the Operating Plan over the next month and be ready to discuss/accept proposed changes in document at the next meeting.
- 2) VP Nomination: CEPC discussed rotation in regards to next Vice Chair. The FWS rep is Kari Cobb; Kari is only FWS fire public affairs staff in the country therefore has limited capacity; CEPC voted and agreed to move onto USFS: Mandy Scott will move into Vice Chair role effective immediately. FWS will move to the bottom of rotation list.
- 3) Annual Meeting: CEPC discussed whether in-person is an option or whether we should plan for virtual, and decided to plan on virtual giving travel restrictions. We will still build an agenda with guest speakers, etc. Proposed date is the week of October 13, likely over four short days (roughly 4 hours/day). All CEPC members will put a placeholder on their calendars for Oct. 14-17 for a virtual meeting. Those with ideas for topics/guest speakers, bring them to our next meeting.
