NWCG is proposing restructuring to consolidate 17 Committees into 10):

Public Information Management Committee (PIC) – formerly parts of PIOSC/CEPC

- a. Education & Prevention Subcommittee (EPSC) formerly CEPC/FPETSC
- b. Fire Investigation Subcommittee (FISC) formerly WFISC

After hearing from Sarah Lee on this topic (see notes below), CEPC discussed initial thoughts: CEPC Discussion on Committee Re-organization:

- Will there be a mismatch with WF Investigation subcommittee, with new structure focus of Public Information management? Shawn should be looped into this conversation. Public Information is a very small part of the investigation piece. If not, where else would they be housed?
- The impetus to get back to the basics seems positive
- No one thought of any fatal flaws.
- How would the proposed budget for the one National Wildfire Agency affect reorganization/large
  incident management. Right now, the existing 5 federal fire agencies provide NWCG funding off the
  top.

#### **COMMITTEE BUSINESS:**

- <u>Chair's update Angie:</u> Restructuring of NWCG committees suggestion is to go from 17 to 10. Angie sent an email to CEPC with FAQs on this topic.
- NWCG Coordinator remarks and news and update Sarah: Restructuring highlights: Next year NWCG will be 50 years old and has grown; it's become difficult to manage workloads. Discussions have been ongoing for several years, and restructuring is vetted through the Executive Board nothing is final yet. Listening sessions are the next step (these will include 3-4 representatives per committee, and reps from NWCG's Executive Board and coordinators). The purpose of the listening sessions is to hear thoughts and concerns, and there will be a form to collect feedback (this form can be filled out by individuals, not just committees). Sessions will continue through the end of June, then NWCG will process feedback. February 2026 is the goal for timing of restructuring. NWCG is not trying to do more with less, but to anchor back to the core mission of interoperability, and restructure across the board to increase efficiency (not just committees); this is the third restructuring over the years, all with the intent of improved efficiency.

The new structure under consideration is set up to have management oversight committees to help provide leadership, coordination, and agency vetting. Groups beneath the subcommittee level can still form do fulfill tasks; they would just not be permanent. The end result will be organization more similar to ICS structure to anchor back to interoperability, qualifications and standards.

In the interim, CEPC should keep doing work as usual.

After feedback is analyzed, NWCG's Executive Board will make decisions on specific positions. Lots of unknowns exist; for example, the potential creation of one National Wildfire Service could affect the reorganization. Reorganizing with the involvement of people who know the current system is ideal.

CEPC's Listening session (June 18) will be attended by: Mandy, Tina, Kerry, Zach or Stacey, and Shawn

- <u>PIO Subcommittee update Kerry Greene:</u> The PIOSC lost one representative (BIA) to the DRP. Elaina La Paz is the new BIA rep. PIOSC met May 22 and talked about topics related to consolidation efforts within DOI/USFS, such as staff who took the DRP working during fire season, PAO availability on host units due to DRP, etc.
  - The PIOSC is working on IPTM rewrite of the S-203 course. SMEs are reviewing content which is a very heavy workload due to lots of content and gaps in material. There's a proposal that the unit on engaging with media would be a good stand-alone training as it applies to a wider audience. An Alpha test for the

new version of S-203 is likely to happen in the fall.

The PIOT position description has been reviewed and sent to Sarah Lee.

PIOSC has been discussing the Pocket Organizer, and who will be responsible for editing it/where it will be available, etc.

NIFC EA will work on creating a video "A Day in the Life..." Candice Stevenson is lead on this. Inciweb development staff has been downsized from 10-12 down to 4 staffers. They won't be able to focus on anything other than maintenance. There have been some suggestions for enhancements (such as recreation layers on Inciweb maps) which the developers are looking into but have limited capacity for now.

- <u>Fire Prevention Education Team Subcommittee update Zach:</u> Stacey provided Zach with updates: FPET is working on a briefing paper on FPET incidents on Firenet. Will need SOPs if this comes to fruition (on file structure, Docbox, roles and responsibilities, etc.). FPET didn't lose anyone to the DRP. They're hoping to address some training issues; consolidation could be positive for the prevention community as a whole as it could address training and more.
- Wildland Fire Investigation Subcommittee update Branden: The FI-210 Powerpoint presentation completed in April has gone out for testing; feedback has been good overall and might lead to a few tweaks. The subcommittee had a meeting in Missoula, MT with the coordinating group and folks in fire lab to get more studies. They also met with USFS staff doing studies on spark arrestors and are getting more info on new ones coming out. Shawn is working on an instructor study guide for FI-210.
- <u>Fire cause task group update Kenny:</u> The task group met two weeks ago and discussed degree of confidence on reporting; there's been no further movement at this time. WPSAPS update: USFS got full funding requested for contract this will help with continued enhancements, the helpdesk, and the new dashboard under development. The dashboard should be rolled out by August.
