Review of existing OFE Requirements and previous contract testing procedures for OFE and discussion on additional criteria to improve OFE Testing outcomes. Discussion centered around aircraft and operational testing in aircraft and with ATBs to ensure that new products approved for use via the QPL were thoroughly tested to ensure success to the LTFR provider and the government. Topics were more visibility testing, additional intermittent inspections of the aircraft used in the OFE, Testing wastewater issues via labs, how many aircraft and what types of aircraft to use, having one aircraft to fly only the product being tested and others commingling product, how many gallons to use, duration of the testing (one season, multiple seasons, until we feel comfortable?), do we need to run product thru bulk bases to see if works with existing government equipment.
