Updates:

- Paul/PMU: EB agreed to annual meeting for board/committees, set for February 2020.
- Quite a few data standards coming out for review.
- Tasking continues on reviewing training related sub-groups. Intent was to better define how NAFRI steering committees fit into NWCG structure, clarify what groups are doing. May end up with some re-naming and modification to mission statements, but doesn't think groups will go away. Perhaps more information coming by the annual meeting in February.
- Certification of S-190 in the next few months.
- New **DRAFT** NWCG nomenclature:

Steward

- An NWCG Committee or subgroup assigned to create, manage, or revise an NWCG position or associated training.
- The steward will strive for unanimous agreement from all stakeholders for changes to the position or associated training. In the case of unresolved disagreement, the steward will determine the most appropriate changes for its subject area.

Primary Committee

- The NWCG Committee with overarching responsibility for an NWCG position or associated training. The primary committee has final decision authority/space.
- For example, the steward for the GISS position is the Geospatial Subcommittee, while the primary committee for the GISS position is the Data Management Committee.

Key Stakeholder

- A group, aside from the steward or primary committee, whose participation in development and review is necessary for success.

o When the Steward does not have responsibility for the applicable

functional area (e.g., GISS is in the planning functional area), the group with responsibility for the functional area (e.g., Incident Planning Subcommittee) is a Key Stakeholder.

o Other committees or subgroups with a significant vested interest (e.g., the National Coordination System Committee is the steward for the Aircraft Dispatcher position, but the National Interagency Aviation Committee has a vested interest in the IPD and related training content).

Action Item: Paul - NWCG to include time-table and flow chart of certification process at some point in the near future. NWCG realizes this needs to be transparent to user community, with roles and processes defined.
