Topic: TECH Transfer TEAM for IFTDSS

Presenter: Henry Bastain and Tim Sexton

Discussion/Considerations: Henry and Tim stated the IFTDSS government development team has recognized that online methods like an extensive Help Center with tutorials, videos, walk-throughs and links to additional resources is valuable and can assist users learn how to "click the buttons" in the application. This single approach however, falls short when conveying the applied use of the system. The "when", "why" and "how" of using IFTDSS for fuels planning is not easily communicated through online resources. Short online courses through the Wildland Fire Learning Portal are a useful alternative approach, but what is really needed is a well thought out curriculum that includes information that is agency and project specific. This much needed endeavor is unrealistic for the Government IFTDSS Team to pursue given limited staffing, technology transfer resources and a need to focus on application development. The proposal is to organize an IFTDSS Tech Transfer Agency Oversight Group (in conjunction with the Government IFTDSS Team and the NWCG FMC) with one representative from each agency to develop a structured approach to delivering the Technology Transfer needed to make IFTDSS a standard tool for general fuels planning and development of unit and project level Quantitative Wildfire Risk Assessments. NWCG FMC to identify their agency representative for this tech transfer group by April FMC meeting.

Decision: Revisit in April with FMC on how to move forward.
