Topic: Role Call

Presenter: Mike Van Hemelryck (NPS-chair)

Discussion/Considerations: Introductions for FWS detailer, John Larson

Topic: Burn Boss Training

Presenter: Heather Heward (U of I)

Discussion/Considerations: Heather presented proposal for testing the Alpha Version of the Rx301/341 course with the Great Basin 301/341 cadre this December. The question is do we move forward with testing this new course framework. FMC was impressed with work that has been done but there is a need to slow down and ensure that the new format will apply nationally across all agencies as well as policy and liability concerns needing to be addressed when it comes to trainers and trainees. FMC will engage in more immediate discussions on next steps working with Heather and the Fire Use Subcommittee.

Topic: Rx Escape Commonalities

Presenter: Frankie Romero (USFS)

Discussion/Considerations: FMC discussed sharing the cost between FS and DOI. Jason will look into using a one-time funding source to meet the DOI share. Jason needs a copy of the scoping document, estimate, and proposal. Bureau leads should reach out to Jason if they have additional thoughts on this.

Topic: RXMG required experience

Presenter: Mike Van Hemelryck (NPS-chair)

Discussion/Considerations: Last minute agenda item and members did not have adequate time to review. Mike will gather more information on this from previous meeting notes and will send it out to folks to review prior to the next meeting.

Topic: Chair/Vice Chair terms

Presenter: Mike Van Hemelryck (NPS-chair)

Discussion/Considerations: Mike and Andy discussed the idea of having the State position continue as a full FMC voting member but excluding that position from having to serve as Chair. This is based on the Fed-centric nature of most of the business that allows federal FMC members to have more knowledge and understanding of day-to-day activities. It would be over burdensome for a state rep to be expected to keep up on all federal dealings and continue with their daily work responsibilities. FMC members agreed. Mike will review the charter and see if any changes need to be made. The current 2-year term limits were also discussed. It was proposed that the committee consider going back to 1-year terms for Chair and Vice Chair OR allow for flexibility in term based on bureau and workload. Some bureaus may be stretched too thin to serve 2-year terms while others have back up and able to cover a 2-year term. Members are send Mike their thoughts in preparation to vote on this at a future date.

Topic: Interagency Fuels Academy

Presenter: Frankie Romero (USFS)

Discussion/Considerations: The Forest Service will be delivering the first year of the Fuels Academy curriculum to 20 FS students starting Feb/March of 2022. This is a three-year progressive academy with different focus areas each year. Content for year 1 is ready for delivery, while content for years 2 and 3 is still in development. Frankie will send briefing materials to the group to garner interest from DOI Bureaus. The FMC will investigate how the FS Fuels Academy could move to an interagency governance body.
