Topic: Rx Burn Courses 341/301

Discussion/Considerations:

Heather gave an updated on where she is at with the revision of the Rx-301-341. The first offering of the revised courses will be in November (virtual) and December (R4-in person). Adjustments will be made after the first offering and that final revision will be submitted to NWCG. Heather would like more feedback from the FUSC. Discussion ensued about modeling requirements for the courses. Science and practice of using models and spatial modeling has advanced but the training has not. There is a desire to build something into the current curriculum that is purpose built for what is needed and it is acknowledged that this will be different than what it is now. Coordination between FUSC and FMC could benefit the discussion about spatial modeling.

Topic: Smoke Committee

Dave gave an update on where things are at with the review of Rx-410, smoke management field guide (final copy for review coming soon), and potential lowering of NAAQ PM 2.5 standards. The group discussed potential impacts to prescribed burning programs if this occurs.

Another meeting with the contractor is scheduled to occur in a couple of weeks so it would be best to get additional fires submitted as soon as possible.
