1. **Haines Index/Lightning Activity Level updates** (Nick Nauslar/Jim Wallmann/Dave Schultz)

Progress was presented to the NWCG Executive Board on July 16th. The progress is on track and going well. At their fires this summer, NWS Incident Meteorologists (IMETs) are spreading the work about the Haines Index and Lightning Activity Level. Some customers know about the changes, while others have been surprised.

2. **Finalization of Incident Response Pocket Guide Haines Index/Lightning Activity Level Removal/Replacement** (all)

Darren Clabo shared his latest proposal text and graphics during our last meeting, and Drew Daily added comments in red in an emailed version on July 16th. Drew also proposed changes to clarify the information for the intended audience. This was accepted by all. Jim Wallmann sent out updated slides to all subcommittee members.

3. **BLM Lightning Contract** (Jim Wallmann)

The previous Statement of Work for the contract from Nanette Hosenfeld and Paul Sopko in 2020 was shared with the working group in an email on July 16th from Darren Clabo. Paul Sopko is the chair of the Lightning Unit (LTNU). The current contract is valid through April of 2025. There is a new local contact in Boise for the BLM Lightning Contract. Contact has been made with Kathy Paulson, to ensure important pieces that were missing in the 2020 contract are caught. The Statement of Work was modified to include language that asks for details in how the prospective products meet the standards set forth. Brian Potter asked that the contract also include a line about documentation and metadata.
