 - O Dave and Heather are beta testing the Crew boss curriculum PTBs for adoption. Heather is the training development lead and has responsibility for task books.

- PMS 560 Standards for Wildland Fire First Aid approved
- Redbook Mesh eyewear language cleaned up and back in the PPE section.

NWCG Training SME Update:

- Will need to develop a transition plan for the 3-course concept. This should be pretty straight forward and from the perspective of the 310-1. Should also outline where agency direction is required for qualifications. McFarland will initiate the first draft.
- Last month Cory presented to the BLM FOG the 3-course concept with general support.
- Added Dave Roy (Snake River IHC assistant supt) to the SME group.
- S-112 just about done with Unit 6 on the web based training. Learned that the 360 imagery for the falling section can't be used to assess the lean at all with the imagery. We will build image packages for each tree. Cory is going to put the tree packages together to include a lean diagnosis. NWCG is going to check out cameras to different crews to capture field images.
- 1 unit left in web-based training. Web based is self-paced and should be about 4-6 hours.
- It is expected the instructor led training will move pretty quickly due to the work completed on the web-based training.
- Lots of work with the illustrator. Going really well.
- We are working to better understand the vetting process for the new course. This will follow standard NWCG procedures and involves instructors unfamiliar with the current course material.
