Introducing Roman Hucks: quick intros from group

Colorado Tree Strike: This was a contractor S-212 program. A student Volunteer Firefighter was struck by a tree during S-212. The Individual was not felling the tree. FS was going to do an info gathering on the incident. Randy Jacks determined this was a private entity on private ground. There was not a large push for a federal investigation. The individual had a cracked skull and vertebrates. Colorado fire camp has a large teaching presence and MOU with Rocky Mountain Coordinating Group. No FLA or LLR. RMCG will be taking a look at their existing MOU's and possibly look more at the Not-for-Profit entities. Look into work area control especially for S-112 and putting that in the instructor portion.

USFS info on accepting S-112: FS is using Thinking Sawyer until S-112 is officially accepted by the FS and NWCG. Trying to push S-112 up to the agency heads rather than just staying at the grassroot/local level. There are currently two paths being taught. S-212 and developing thinking swayers. Continued work on developing a clear path to get that out to people. The intent is to find a

way to disseminate solid direction on how to implement S-112, S-212 and S-312 to people and how to incorporate the correct training for people and document things correctly to provide Sawyers quals.

Hazard Trees (Chadwick): Unavailable

USFS Chainsaw Program (Apuzzo/Mclaughlin): Training and getting into the season, Looking into new helmets as well as ANSI and NFPA 1977. Currently setting up a project to dive into international projects and do 3<sup>rd</sup> party testing against our current helmets. They have lateral protection and have better retention to stay on the head. 2024 Redbook has changed and specifies NFPA 1977 approved chaps and there should be more options for Chaps in the future. Old FS Chaps will still be compliant. Forest service policy is lagging but will change. Clogger out of New Zealand is one of the leading and driving companies for this. If the Chaps have the 1977 stamp they will adhere to policy. DOI will be able to implement the new Chaps immediately.
