#### NWCG Airtanker Base Directory / Directory App

- The Airtanker Base Directory Unit has been working with the app developers to add additional options. The goal is to have the ability to print it in the same format as the hard-copy versions were. Another goal is to have the airtanker bases set up alphabetically with tabs that are formatted like the former hard-copy versions were.

### Standards for Airtanker Base Operations Unit (SABO)

#### Airtanker Base Training and Qualifications Unit (ABTQU)

- The ABTQU has been working on airtanker base modules. Due to a lack of staffing across many bases there are often not enough personnel to make a module successful. The potential for additional airtanker base positions may make modules more successful in the future.
- Airtanker Base Operational Risk Management Unit (ABORMU)
  - The GAR has been updated to auto-populate and the ABORMU will be meeting later in January to finalize the roll-out sheet and then send to the IABS for review.

• The ABORMU plans to meet with Donna Schope to discuss the potential for utilizing PRISM checklists in the future.

## SEAT Unit

- Information regarding the Fire Boss SEATs has been added to the inspection sheet. This will be reviewed by the IABS and then disseminated.
- The SEAT Unit, ABC, along with the SABO Unit are discussing wingtip clearances for SEATs.
- There are discussions regarding the number of SEATs that can be administratively managed by a SEAT Manager. Currently it is three and there is a possibility that it will be increased to four.
