Discussion/Considerations:

- Change Tracker review, 1-19
 - Supported by the committee members
- Additional change request #20 proposed
 - CT presented suggested proposal change to table 1 of the 2023 SAS
 - Concerns from committee members
 - Change the ATGS/ASM requirement from “ordered to considered”
 - Suggestions to record the “situation” column
 - Has to do with initial attack vs extended attack, maybe add the word initial attack to the verbiage



- The situation has come up with Type 3 and Type 2 extended attack fires with a lot of UAS usage, not just during initial attack.
- Recommend splitting the first row
 - Manned 3 or more aircraft (row 1)
 - Manned and unmanned in proximity (row 2)
- Row 2 removed the word proximity and change to area of operation.
- Concern with the change of wording to “over the fire”. Concerned resources will use that as a scape goat to continue operating with out an air attack.
- All present committee members agree and support splitting the row and changing the wording and requirements
