IATS on call suggests A-200 is important training, per the One-Way NWCG Position to IAT Position Crosswalk in IAT Guide, there is no requirement for A-200. (e.g. HECM → Aircrew Member); currency of IAT Positions shows A-200 training every 3 years

Woody suggests Operations Training Committee (OTC) to recommend A-200 every 3 years via 310-1 National Incident Management System: Wildland Fire Qualification System Guide PMS 310-1 (NIMS:WFQSG). **Note:** NWCG is performance based; IAT is training based
