0920: Fire Reporting - (20 minutes) Dianna Sampson

- InFORM Update
 - o Forest Service, BLM, BIA, NPS plan to use beginning January 1st
 - Approximately 35 staff testing at this time, need to fill-out both WFMI as well as INFORM
 - Mobile collection is available through Collector & Survey 1-2-3
 - Inspector is webform to edit
 - Once certified, data will push back to other systems
 - Agile development update every 3 weeks testers are finding bugs and those are getting fixed
 - Majority of federal requirements are consistent
 - O Nice reporting tool includes graphical display of summary information
 - O Spatially enabled will include point & polygon data
 - Not yet sure how to make canned reports available (WFMI/FamWEB replacement)? maybe dashboards?
 - Working on rollout, most recent went really well
- Brainstorming questions unable or difficult to consistently and accurately answer (feedback from the field)

1000: (20-40 minutes) How to complete Interagency online storymaps/FMPs

- Hosting (NIFC AGOL vs. Agency AGOLs, other options?)
 - O NIFC org has worked well for Nevada
 - Interagency is important
 - Standards

Want to:

look at FMP Spatially across boundaries

- Description of appropriate "type" of fire
- Fire-relevant management direction

Avoid No fire here neighbor says yes in operationally difficult location (align w/ neighbors where possible) (Suppression difficulty), PODS may be useful

Visible in webmapping, mobile, decision support applications

Scalable (capable of displaying relevant info at local as well as national levels, and audience)

Challenges:

NEPA Compliance

Approval Timeframes & process (interagency, including states)

Expertise, availability of technical specialists in the field to develop

Data currently lives in too many places (mobile, PC/Web, applications)...need flexible centralization...so only loaded in a single spot

This will be a longer term topic on future agendas as we work to define the IT Capability/Data requirement that we're interested in

- MIST (Andrew Bailey) -
 - Minimum Impact Suppression Tactics and Minimum Impact Suppression Techniques used in different documents
 - Members felt that there was utility in both uses
 - Recommendation: add (AKA Minimum Impact Suppression Tactics) to existing NWCG definition
- Followup Fire Management Program discussion, no need to pursue NWCG definition at this time (BIA is planning to pursue a definition for their use, request for Reeve share updates)
