### WFDSS:

WFDSS is a FS "owned" IT project (Note after the fact: all IT projects have a system owner and currently all wildland fire IT applications governed by the Wildland Fire Information Technology (WFIT) process are owned by either DOI or USFS) and will be using FS IT structure

-DOI is working on representation with WFDSS Next Gen (Information sharing between WFDSS and DOI) and help balance the different DOI department needs/priorities(DOI product owner?).

-Need to define policy for records to meet interagency requirements

-IFPC looking to clarify roles/responsibilities integrating with state representation with WFDSS

-Charter development between USFS and DOI.

Work on user engagement strategy: Would encompass reaching out to GAE's, Fire Behavior community, fire planning community (IFPC), research community

Ensuring fire planning is incorporated into the new system

A flow chart was developed for IFTDSS that describes the relationship between user groups and NWCG FMC that may be useful to assist (Is there a place where user advisor groups can determine involvement with WFDSS next gen.?) IFPC and the nextgen team evaluate what the role of IFPC would be in the transition to next gen WFDSS?

### InFORM:

-USFS, some states and all of DOI Bureaus except of FWS on board this year, possible batch upload for others at the end of the year.

-Link on fire reporting subcommittee page under "data management committee" for InFORM demos.

-AK working for interagency approval of fire reports. \*Questions regarding agencies approving or certifying fire reports for other agencies.

BLM working on IM for InFORM, working to clarify what is needed for records management for DOI.

\*Consolidate concerns regarding fire reporting regarding BLM record(s).

\*What constitutes "official" BLM record? Work being done with records management to clarify what the document needs to be.

After discussion with IPSC representative, state feedback on bringing READ/REAF into the 310-1 will be critical Need to beef up the Request for Change, particularly the interagency nature of the position outside of Feds.
