*Looking to use a feature service, hosted external to the WFDSS application itself. Four buckets within a single “dataset”*

- *Multi-unit*
- *Unit-wide*
- *Non-overlapping*
- *Overlapping*

*Andrew Bailey still working on draft white paper*

*Very flexible, like the direction of where we’re headed. Much easier to keep current if hosted in a different, cloud-hosted data.*

*Not yet finalized decision that functionality might need to “live” in the Nextgen WFDSS App (decision expected: ~February)*

*Short BP to explain context to FDs, others. Justin, Missy, Reeve- review (final draft by Mid-January)*

Will still need to develop a data standard, that would describe a one to many relationship
