- Donnie agreed to take the lead for IHOPs in developing the minimum standards for helicopters to be on the source list.

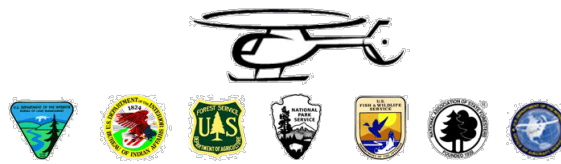
