Updates-

- Bea- USFS, working towards virtual manager workshop trainings for next year.
 ASAT in region 5 went well. Finding reports of less camp crud. Seeing increases in request for 2-1.
 - Extending some AC contracts to oct 15th and day to day Working on next gen type three contracts
- Nic- NPS- Extending some crews day to day as fire and short haul modules.
 Cards that were extended by OAS through this summer due to COVID impacts are expiring so we are working through that.
 - There have been some issues or potential issues with short haul and rappel being allowed on other jurisdictions. Bea and Nic will discuss off line.
- Bryan- Rapid refuel being added to type 1 & 2 contracts, language will be similar to USFS language.
 - Have extended all helicopters until oct 31st day to day except MT crews due to weather.
- Matt- OAS- Helmet have been extended to Jan 1st 2021
 Moving forward with training sites and locations for 2021 training.
- Chris- FWS we have a 120 day contract out for burning in Dec 2020.
