- Resource Unit Leader determined best positional account for MS Voice per IPS
- Sent Email back to Tara after 2/14 call: Hi Tara, we were able to discuss this today on our Incident Planning Subcommittee call and the consensus of the group was that if we could get that second MS Voice Line associated with the Resource Unit Leader position account. Reason for this is we saw the need for the phone line to be an initial priority for Check In, then as the incident was established that priority then transfers over to DMOB. The RESL position is best to oversee that, hope this makes sense, if not let me know.

Whoever it is assigned to (as long as it's in Plans) having that second MS Voice Line is going to be a huge help, thank you!

Hi Dylan & Robin! Another licensing topic! We are looking to expand the MS Voice number to another
position beyond the PIO that's currently the only position assigned a number if requested. This would be
for a position that needs/uses a 'direct line' number. We are looking to add to one position as
we gauge support needs and DMOB was the most common request we saw last year. If this can go in

- Addition of TNSP, FBAN, LTAN, SOPL to Shared Inbox and Approved Positional Account Requests
- Position Qualification Evaluation for SITL and DOCL: Task Team is recommending the Incident Planning Subcommittee evaluate both SITL and DOCL to ensure the position qualification are accurate. For SITL, the task team felt that with the complexities and changes in the position responsibilities, there is strong rationale for reviewing the required training and experience. ICT4 was removed as a prerequisite for this position in 2015 and the S-346 course was moved from required to other training which supports knowledge and skills, in an effort to increase capacity.
- Discussion on appropriate level of operational qualification(s) needed to be proficient as SITL. Majority of group felt it was worth or taking a look at current IPD and recommending edits with further analysis. Dana Carter will work as POC for the group and complete additional review of topic and present options at next month's meeting for decision.


