elSuite Questions (email from Jill Lipsey emailed 6/1)

Thanks again for taking the time to meet with us during your meeting last month. We had a follow-up question regarding one of the changes we discussed and then one we forgot to run by you all.

- The first one is in regards to adding a Section to the ICS-203 Form. You all indicated the ability to add blank lines is needed, which is current functionality. However, this change request is specifically for adding a Section to the form (ICS-203 attached for reference). After taking another look, it seems like adding a Section would be changing the form since the block numbers would no longer be the same and the form itself only has existing Command and General Staff Sections. I wanted to confirm this is desired functionality, despite that. We are reluctant to implement anything that changes the basic layout of the form.
- The change request I forgot to mention on the call is regarding the ICS-204 and adding Channel Name to Block 8 Div/Group Communication Summary (ICS-204 attached for reference). The user indicates there is a Channel # but no place where the Channel Name displays, and they felt that would be helpful. The name is currently on the ICS-205, just not on the 204.
- Feel free to share with anyone as needed. Please let me know what you think on these two changes when you have a chance.

Proposed IHF Definition for submission to NWCG Data Standards (Rader):

So... my recommendation would be to qualify business rule #1 in some way (but I don't know what that
seemingly missing rule is). Maybe it's something like.... Wildfire incidents whose management is formally
delegated to an Incident Management Team (Type 3 or higher, including NIMO or CIMT), require creation of
an IHF. SDL

As I was preparing the request for Incident History File to go out for review, I began thinking about some things I am learning in a book Roshelle is having us read: Business Knowledge Blueprints. As a result, I would like to make a

couple recommendations for the term before putting out for comment. Definition as proposed in the request: Wildfire incidents on Federal lands require creation of an incident history file (IHF) to document significant events, actions taken, lessons learned, and other information with long-term value for managing natural resources. The host unit is responsible for retaining and managing the incident documentation package including the IHF, temporary records, and financial records. The document types that need to be included in the IHF are located in the Master Documentation Index and are updated based on agency record retention schedules. The Master Documentation Index can be found in the PMS277.

My proposal includes taking some of the definition and calling out as Description and Business Rules. I suggest the following:

Proposed definition: On a wildfire incident, documents information with long-term value for managing natural resources.

Description: The Incident History File may contain information describing significant events, actions taken, and lessons learned.

Incident History File Business Rules –

- i. Wildfire incidents on Federal lands require creation of an incident history file.
- ii. The host unit is responsible for retaining and managing the incident documentation package including the IHF, temporary records, and financial records.
- iii. The document types that need to be included in the IHF are located in the Master Documentation Index and are updated based on agency record retention schedules. The Master Documentation Index can be found in the PMS277.

We are moving towards a definition being the essence of the term (concept), supported by a description, business rules, and examples. More to come on our maturation in future DMC meetings. Please let me know if you have any questions. Thanks in advance for your time.
