Group A will consist of positions that are related to operations/safety/have a fitness level associated with them (appx. 55 positions) and Group B will consist of all other positions (appx. 65 positions). Group A positions will be addressed by NWCG Training over the next several years. Position Stewards for Group B positions will have the opportunity to update their current training if they wish using the Level 2 Certification. NWCG will step out this Level 2 process and post it online, similar to how IPD development was addressed. Implementation Guide will be shared out sometime this fall. NWCG Training has completed a review of four positions that will go to contracting as soon as possible. Working to fill vacant positions, including two new Instructional Designers and two Training Specialists. The on-line version of S-190 is on track for release in the fall. Developing an entry level training class for wildland fire positions based on common IPD statements. Provided a WFSTAR update.
