Will write the final statement of work and put out for bid in the new year. Received the updated material for the S-490 course. Joined the After Action Review for the Southern Area delivery and gathered feedback that will help shape how to move forward. Training specialists sat in on the Forest Service delivery of the Thinking Sawyer course in Missoula. One suggestion presented to the Training Delivery Committee was to remove the FFT2 requirement from the S-212 course to allow a wider audience to take the course (i.e., Trail crews and backcountry horseman). Next generation Position Task Book (PTB). Received overall positive feedback from testing. Updates focused on wording, grammar, and formatting. Annie presented two versions of the PTB, the original version that went out for testing and an updated version that incorporated the feedback. New version combines the evaluation and verification record pages to a single overall rating page, and decreased the incident record to a single page, which would decrease overall size of the PTB. IPSC recommended additional updates for the new version. Will review and vote in January for support. NWCG training will be working on training videos on how to manage new generation PTB.

The All-Hazard world is not going to CIM, NIMSIC discussion needed on how to utilize all hazard personnel on wildland fire incidents. Incident position descriptions were finalized for CIM C&G and sent to NWCG to post on web. Expect to be up in January. Transferred CIM Position Task Books to the new format and will be posted on the web in January. Edits to the Risk and Complexity Assessment were sent to NWCG to update the PMS 236. Updated Field Evaluation guidance will be completed by the end of the year. January 1st tasking is to provide Executive Board with a nationwide and systematic transition plan with the intent of full CIM implementation of April 2024. Marlene will take components and put into a written format and get out to the committee when complete. Type 3 and Unit Leader pathway to CIM. Executive Board approved short term pathway.
