Instructional Designer position has been filled with a start date in January. NWCG training catalog is being migrated to the Wildland Fire Learning Portal (WFLP). The last of the non-required courses are in progress of being migrated, with WFSTAR coming at a later date. RXB2 position package minus the updated PTB is available to the field. RX-300 has been certified and available through the WFLP. Will draft memo to address RX-300 being equivalent to RX-301/341 and both options will be available until January 2025 when the PMS 310-1 is updated. Next generation PTB is intended to use in conjunction with the position standards. Next generation PTBs will move to position specific PTBs and no longer include combined positions. For current combined PTBs, there will be a coordinated effort as positions move through the IPTM process to ensure common tasks are credited to the trainee. Next generation PTBs will be rolled out as positions move through IPTM. Working on communication plan for the transition, will have to IPSC by the January meeting for review. IPSC members will vet the next generation PTB through their respective agencies and be ready to discuss at the February meeting.
