MONDAY, DECEMBER 2 - CMUL MEETING

WELCOME & INTRODUCTIONS

(WOOD)

CMULs, LC members, and guests introduced themselves.

CURRICULUM MAPPING & LEADERSHIP LEVELS UPDATE

(ELLSWORTH/MASON)

Mike Ellsworth and Ted Mason provided updates made to the curriculum mapping following the spring 2019 meeting in Santa Fe. Mike and Ted incorporated leadership levels into the framework. Mike identified the various levels by position as well. The map will be used as a curriculum management tool, outreach document, and a roadmap for IPDs.

CMULs discussed the various categories within the map.

LEADERSHIP CURRICULUM UPDATES

(CMULs)

L-180/280

Ashleigh will be on a short detail to Boise to work on leadership initiatives, including L-180/280 revision and the *CMU Guide*.

L-380

Joe Williams and Matt Lynde were unable to attend the meeting. John Wood presented information from the CMUL notes.

LJ Brown is the point of contact for the agency version. Rowdy Muir retired.

L-381

LJ Brown and cadre will be evaluating a new agency lead instructor for the PNW the week of December 10.

L-480

Four deliveries are scheduled for the 2020 training season. The task of recruiting additional providers continues.

Jim's operational flexibility to work on leadership tasks has diminished. Jim will engage Paul Cerda more. Andre Evans expressed a willingness to contribute as well.

Curriculum changes will be incorporated in the mapping as soon as possible.

L-481

George Risko reported the course is static. Presently only one provider is approved for delivery.

L-580

Kelly Woods has edits for the curriculum map.

The beta Chickamauga/Chattanooga L-580 Staff Ride was a huge success and will be ready for delivery in November 2020. Chris Wilcox and Kelly Woods were on hand to evaluate. Many conference group leaders were approved during the beta delivery.

OMNA's operational flexibility to support staff rides is diminishing.

The San Diego County Mega Fire Case Study will be held in late February in Redding for the NPS and California OAS. Also included in the delivery will be a mini site visit to Whiskeytown/Carr fire.

TUESDAY, DECEMBER 3 – LEADERSHIP COMMITTEE MEETING

WELCOME & INTRODUCTIONS

(FENNESSY)

On behalf of Orange County Fire Authority, Chief Brian Fennessy welcomed everyone and provided a brief history of his involvement with the committee and as preparation for the panel discussion Wednesday afternoon.

LC and ad hoc members and guests introduced themselves.

SELF-CARE/WELLNESS INITIATIVE

(DR. WATSON)

Dr. Patricia Watson, National Center for PTSD, briefed the committee on the Stress First Aid peer support model. The model has been mapped onto various governmental agency platforms (FEMA, Navy, Marines, and the National Fallen Firefighters Foundation) and shapes a way of thinking. Stress First Aid should be considered a facet of leadership development, fitting well with self-care and wellness.

Kim Lightley consulted with Dr. Watson for adaptation of the model created for the National Fallen Firefighters Foundation for use in wildland fire. Through a multi-year contract for Dr. Watson's services, Kim is organizing Stress First Aid train-the-trainer sessions to be held in Tucson in February 2020.

LC members had a robust discussion regarding the critical need for self-care/wellness within the wildland fire service. Members acknowledge the need to coordinate efforts with the Risk Management Committee's Mental Health and Wellness Subcommittee.

Action Items:

- Brief the Risk Management Committee (RMC) on Dr. Watson's presentation and recommend the Mental Health and Wellness Subcommittee pursue an educational campaign using the Stress First Aid model and report out at the spring 2020 LC meeting. (Ted Mason)
- Submit a joint NWCG budget request with the RMC to support self-care/wellness initiatives and training by January 15, 2020. (John Wood and Ted Mason)
- Consult with the IRPG coordinator to incorporate self-care/wellness and report out at the spring 2020 LC meeting. (Mike Ellsworth)
- Incorporate self-care/wellness in to the curriculum with Dr. Watson's expert assistance by February 14, 2020. (All CMULs)
- Determine what parts of the Stress First Aid course could be placed in the Leadership Toolbox and report out at the spring 2020 LC meeting. (Monica Morrison)
- Consult with Travis Touchette about creating a self-care/wellness module for the annual fireline safety refresher and report out at the spring 2020 LC meeting. (Mike Ellsworth)

KNOTT'S BERRY FARM SITE VISIT

(OCFA)

LC members met with emergency operations personnel at Knott's Berry Farm. Members say how the private sector has adapted ICS to respond to emergency situations. Unity of effort and strong relationships have led to successful responses during incidents. Every employee is a leader and part of the response plan.

LEGACY PANEL DEBRIEF AND TAKEAWAYS

(WOOD)

- Leadership principles should be contemporized to keep them relevant.
- Co-location with other committees would be helpful.
- A change to the L-380 audience is justified.
- Benchmarking is vital to the growth and improvement of the program.

RISK MANAGEMENT IN THE WILDLAND FIRE SERVICE

Mark Smith provided an in-depth presentation regarding risk management in the wildland fire service and why risk management is a leadership function. Risk management should be approached with objective decision making and expressed through leader's intent. The present system is too subjective.

NAVAL ACADEMY BENCHMARKING VISIT

Shane Olpin, Jim Shultz and John Wood visited the Naval Academy in Annapolis, MD. This benchmarking opportunity resulted in a partnership with the Academy and an open invitation for LC members to audit classes, access to resources, and a look into instructor development.

NWCG Informal Tasking

Deb Fleming reminded the LC of the NWCG's Executive Board request from their June 2019 meeting. "The Executive Board requests the Leadership Committee discuss the process for all instructor qualifications in Fall 2019. Report back to Executive Board post meeting." This request followed a request from the Pacific Northwest's request to self-certify instructors. That request was denied by the EB.

John Wood was under the impression a phone call following the meeting was sufficient. Additionally, LJ Brown will be evaluating a new agency L-381 instructor the week of December 10, 2019.

The LC reiterated that all information regarding instructor qualifications and certification is located in the *Leadership Curriculum Management Guide*. John Wood will follow up as necessary.
