NWCG Update

NWCG website should go live in the next couple of weeks.

IPTM/Revisions of EDSD/EDRC Positions

EDSP and EDRC are moving forward.

IADP/Aircraft and Supervisory/Coord groups will meet in Boise the last week of April to start the IPTM process and discuss what each position encompasses.

Response from FS should be back with NCSC in the next couple of months.

Aircraft Dispatch Requirement

Formal recension letter from Alex Robertson has come out stating IA dispatchers can continue to dispatch FS contracted aircraft but the center must have a fully qualified aircraft dispatcher on order at the minimum.

Website Update

Jeff will submit updates to Katie to send to the website developers.

Sean will send needed correspondence to Jeff for inclusion.

DCAT/WIFIT Update

Met with WIFIT chair and opted for IRWIN to complete disposable prototyping for DCAT.

Creating a dashboard would require low coding and adding more pieces such as supply.

Currently there are good reports built in IROC, but it still requires tweaking and data entry by the user.

The team is trying to automate as much of the data pull as possible.

The DCAT tool could be made available earlier than the v10 release of March 2025.

Some coordinating groups have had to set out clarifications regarding how the cost analysis tool will be utilized based on how some centers are manipulating the data entered, ensuring federal employees will obtain 55% cost to government.

States are still trying to figure out their percent cost and salaries based on low personnel numbers.

On a good path to figure out costs for facilities, but the labor cost has caused some shock.

At some point, there will need guidance from higher levels for the DCAT tool to be most effective based on unadjusted

Request from the community to include staffing as a factor for the tool.

Recommend waiting to send out a message once the product is complete and ready to be utilized.

Presenting at next WIFIT meeting on April 3.

International Incident Standards

Task group was created to discuss international fire reporting and concerns that needed to be addressed.

Discussed fires originating in US, fire reporting implementation challenges, fires originating in other countries and crossing into the US, and importing/exporting international resources.

The group reviewed all NWCG Event Kind Categories and recommend several revisions.

Request "Foreign Incident" for fires that have originated elsewhere and burned into the US.

Request "International Mobilization" as an event dealing with effective and timely support by mobilizing resources internationally, including importing and exporting resources.

Business Rule recommendations have been drafted with input from many of the frequently impacted GAs and states.

The authority to create the incident record would lie with the US Organizational Unit which is signatory to the agreement.

State financial code and/or FireCode will be generated against the US Unit Identifier affiliated with the agreement signatory.

Standards approval by NCSC will be sent to NWCG for review and a 30-day commenting period. -Support

Dispatch Position and Curriculum Management

D-311 is moving forward with WildCAD-e and the Bighorn group and should be out for alpha testing in fall 2024. The class environment will not be integrated into WildCAD-e.

D-312 work will begin once D-311 has been completed.

D-510 meetings are ongoing with kickoff in April.

National Interagency Computer Aided Dispatch

Draft SOPs have been sent out to the group, following the same set up NCSC has.
