Will be looking to get the language in the 2020 Interagency Standards for Fire and Fire Aviation Operations (Redbook). This is a federal only decision and will be discussed at the Fire Management Board (FMB).</li><li>Discussion regarding which committee it was most applicable to place the Fire Chemicals Board.</li></ul>	NIAC members recommend the creation of a Fire Chemicals Board be under the ETC.
