General updates

- Griffin reported that Mattfeldt spoke with DMC, IPSC, and WFIT about endorsement tasking and
 potential impacts to their committees. Mattfeldt and Griffin are working on a draft tasking
 memo (due at the next NWCG Executive Board meeting on 9/16). No further information
 available for the group at this time.
- NPS approached Mattfeldt about adding a member to this committee as per past practice. No name available at this time.
- NIMS Alert 12-20 was recently distributed with Swiftwater Rescue-related position typing
 definitions. It's more relative to DOI given their technical rescue activities but take a look and
 provide comments directly or through this committee.
- Jeff Hughes spoke on NIMS Coordination Group meeting although he was only intermittently engaged due to other responsibilities. The group talked about what they are planning to do as they get back up to speed at a higher level than he recalled on items such as endorsements and data. Mattfeldt probably could provide more background. Shelly Pelcher, as project officer for the NIMS CG, added it was second meeting with good participation. One topic was a name change with the proposal to change the MOU to the NIC CG as the group encompasses more than NIMS responsibilities. The group will include a Planning Integration Branch and Technical Assistance. Subgroups of Technology, Communications, Training, and Law Enforcement will be expanded upon. As things progress, additional subgroups can be added. The group is also interested in reviving the Incident Complexity Guide for planning and training purposes. Next steps are another meeting for the main group in September and then LE and training subgroup meetings. Looking for more participants for training and LE. She's also looking for assistance with document review. Kehmna offered his help and Sachs recommended our NWCG training committee folks as well.
- Chris Darlington of FEMA participated in lieu of Hank and provided an IMT update. The challenge is availability of SMEs this year; they have been attempting to determine who from the earlier recruitment is still available. As of now, twenty-seven are currently still available allowing for two to a group. Each group's project officer will send the SMEs a folder with info on the positions in the group and a checklist of items to work on. They will likely accept more SMEs as they come forward. Due dates have been established for each role and there is hope for a national engagement period (would like 45 days) for all IMT positions; they are shooting for

October. Kehmna knows of many folks in CA with this particular experience who he can potentially tap for SMEs.
