# **Beginning Discussion**

Review of committee mission statement

Many of us are involved with multiple projects and serve on several committees which can sometimes overlap. The beginning of a new year is always a good opportunity to review, reflect and refocus to keep us in alignment and innovate for the future.

#### Mission Statement

The National Incident Management System Integration Committee (NIMSIC) provides national leadership related to the National Incident Management System (NIMS). The NIMSIC provides guidance and expertise to the NWCG regarding the integration of NIMS, National Preparedness System, and All Hazards concepts, standards, and requirements into the development and implementation of NWCG standards, guidelines, qualifications, training, and other capabilities.

### **Primary Objectives**

- Provide expertise and guidance to the Federal Emergency Management Agency National Integration Center and associated committees, work groups, and partners relative to the NWCG mission.
- Develop internal and external partnerships to minimize redundancy and promote NIMS compliant interoperable standards between NWCG and other federal, state, tribal, territorial, local, public, and private stakeholders.
- Establish maintain, modify, and prioritize existing and desired information and technology (IT) capability requirements related to the NIMS.

Deb – discussed strengthening collaboration with the different NWCG committees. She highlighted when requests (i.e. NIMS Alerts) come out from FEMA, what committees need to be involved for a collaborative response from NIMSIC and subject related NWCG committee(s). This will help strengthen collaboration. Unsure if this should be addressed more clearly in the mission statement and objectives or improved upon informally internal to the committee.

- Mike – Likes the idea. He has been engaged in some reviews in the past and they were a little surprised to hear from this group. Curious if there is an idea to assign someone to work with a committee.

### Review and discuss committee structure

Reviewed current roster taken from website and discussed potential changes.

### Proposed potential changes:

- Restructuring from Co-chairs to Chair and Vice Chair.
  - If the move to a vice chair scenario is decided, should the vice chair rotate? What frequency?
- Add role of support staff.
  - The support staff role may be filled by a primary member to maintain meeting notes and track committee projects.
- Add National Park Service as a primary member.

Steve – Currently role of the chair is in Position Description and Performance. Suggested moving from Co-chair to a vice – chair structure.

- Mike provided history behind this change during a period of transition and with location of
  positions (Boise and DC). Given the ability we have had/demonstrated during this time of virtual
  work, it might be a good time to move it back to vice-chair.
- Deb In her experience, co-chairing is difficult (both doing the same thing or each thinking the other is doing it) unless there is excellent communication.

Steve asked for a consensus for Chair-Vice chair structure, general consensus was confirmed.

Should the Vice-chair rotate between other committee primary members?

- Ken Don't want to see it just being two people doing it all the time.
- Mike The Vice-chair would need to come from the Primary members only according to NWCG guidelines. In favor of this but need to have a decent overlap to help ensure a smooth transition
- Gordy and Zeph were in favor when Steve talked to them.

- Jeff In favor. From the USFA, if there were things that needed to be done by the chair in Boise, it would be difficult for someone from USFA or DC to be able to brief them.
- Deb clarified that the Chair would be Steve's job position.
- Paul Had no problems with this and has no problem with Mike staying on as vice-chair for another year and then rotate.
- Mike was okay with this
- Deb Makes sense to her
- Ken Before we transition, might want to start the transition 2-3 months ahead of time to ensure the incoming vice-chair has enough time to get up to speed.

Mike will maintain Vice-chair for 2021. Committee will select and transition a vice-chair for 2022.

- Steve talking about adding an Admin Support type position to take notes, send those notes for posting to the NWCG page and maintain tracking tasking.
  - Mike Proposes having a committee member volunteer to take notes for the next meeting (if they can't they find a replacement). This would give more ownership. We do not have that many taskings that we can't keep track of or handle (maybe have a spreadsheet on the web page that we keep updating).
  - Steve likes the idea of a member being assigned to take notes. Designate the note taker for the next meeting at the end of each call.
  - o Mike, Deb, Paul, Ken, Jeff support (Steve will talk to Zeph, Gordy and Jason)

Liaison to FEMA – This is not typically a voting member on NWCG Committees. Steve feels that we should leave it this way.

- Deb confirmed that this cannot be changed. On the website, it clarifies roles and requirements for those roles. NWCG is a consensus organization. We really don't "vote" it is discussion oriented and in the end we should all talk and reach consensus but not all have a vote.
- Follow-up after the meeting confirmed, Hank Rowland will be the primary FEMA Liaison and Tiffany Hudgins will be the alternate.

Should we look at adding another Primary member representing DOI (NPS). Mike has a recommended name but has not contacted them yet.

• All on the call supported it.
