Discussion and Updates

Endorsements (Implementation Group) – Ken Kehnma

The Endorsement Task Group (Implementation) met on 5/28.

The Task group recommended the following:

- Set a meeting with sub-committee from the NIMSIC ETGI to test drive the revised Endorsement Analysis Process flowchart using the Endorsements crosswalk/spreadsheet for PIO done by Deb Fleming and James Christian.
- Invite a representative from the Position Steward for PIO to participate in the test drive process.

The sub-committee met on 6/10 to perform the first Endorsement Analysis Process test drive on the PIO position.

- At the conclusion of the meeting, the subcommittee had a brief discussion about the use of Zoom and Google and the need to move to another platform accessible by our federal partners.
- The subcommittee made the suggestion/decision to move to MS Teams

Ken Kehmna and Deb Fleming held an informal debrief on 6/11 to discuss first impressions of the first Endorsement Analysis Process test drive on the PIO position.

- Lessons learned:
 - The Endorsement Analysis Process Flow Chart needs an associated job aid/instruction sheet clearly explaining each of the steps and defining key terms/objectives.
 - An outline of must-read documents and critical information must be determined prior to Position Analysis meeting.

- It is essential that representatives on NIMSIC, Position Steward and the Training Program thoroughly review all "Information required on position requirements" prior to Position Analysis meeting.
- The Position Analysis meeting should include more than one participant from the Position Steward. This will give them an opportunity to make decisions and recommendations through consensus.
