DISCUSSION

Intel Course Update

- Date set for April 12-16, 2021. Held virtual.
- To be held on Wildland Fire Portal network https://wildlandfirelearningportal.net/login/index.php.
- If anyone's interested, could still use some help when break-out tables occur as table coaches.
- Megan may need help with her sections as she is doubled up and long.
- Date for sending out class info and if still open. Troy will look into it.
- Unit Instructors need to look at their units and make any needed edits.
- Per TJ, KY used breakout feature in Teams for IROC training and they said it went very well.

- Next Cadre meeting on Jan 27th on same Teams link. Parker uses State email not FireNet.
- Will course material be available after class? Troy will look into it.

209 requirement changes

- Daily 209 submissions (Troy), 2 parts: 1st part complete 209 weekly if fire not contained within 72 hours, regardless of size, strategy, etc.
 - Who's enforcing this requirement? What other GACCs enforce this rule
 - Kate had sent out an NMAC document stating how they came to some of those elements.
 Attached in email meeting invite.
 - Is this still relevant or do we have other systems outside of the 209 that we can grab some of that data?
 - Fields unique to 209 are applicable to when we are actively doing something on the fire. The rest of the data provided info to what the fire is doing can be found in CAD, and in the data stream available.
 - Do we need to do the extra workload, especially for the small and/or monitor fires?
 - Alaska does enforce and end up doing a lot of 209s for the monitor fires, lots of weekly 209s.
 - Great Basin follows this rule and pushes the centers to submit weekly 209s.
 - When looking at EGP, after 48 or 72 hours, sometimes those fires drop off their programs.
 - Suggest changing verbiage to GACC may request 209 if criteria met, during higher preparedness levels? For resource competition if requested.
 - SACC doesn't enforce rule.
 - Rocky Mtn. has in their policies that a Center Manager can request a 209 at any time.
 - Main issue is resource tracking. However, fires without resources or requesting resources it seems like more of a workload.
 - Megan discussed with Sean and received same result Marco got that it's not really enforced nationally, more at the GACC level. It was presented to NMAC to remove and was shut down. Discussion is good, however potential to get changed for National Mob the deadline has already passed. Potentially best way moving forward to get changed is to present white paper to NMAC to see what they think as they are the ultimate decide to make changes to mob guide.
 - Do we need to form a group to address this to present to NMAC? Any interested folks gather info and share.
- 2nd part Full suppression incidents will submit until fully contained. Should there be an added option for weekly approval from GACC or NICC? For those long duration fires that units don't want to call out.
 - Received some emails about how some folks worked around that by changing strategy to less than 100% full suppression.
 - Some R-5 forests have it in their operating plans that all fires will be Full Suppression.
 - Rocky Mtn., people are reluctant to put fires in monitor or other non-full suppression strategies based on politics. Cultural issue that they run into.
 - Direction in Rocky Mtn., as fires near containment they were given the option to not submit daily 209s under full suppression strategy as its nearing containment and only a few resources on fire, saw a lot of fires change to less than full suppression type strategy. They liked the idea of once a week, moving forward.
 - Marco put paper together with fire planners a while back, over year and half ago, about how we could utilize other decision making applications such as WFDSS and have that as the strategy source, as the Authoritative Data Source, that automatically populates, particularly team fires or larger fires, it would populate or gray out the 209 and be more reflective and consistent of the line officers decisions. Often not seen where the 209 reports one strategy and doing opposite in WFDSS.
 - Instead of strategy slider bar, some radio buttons you can click, so that it's consistent across various applications.
 - Get the right paper together, the PSOG could be a good path to present to NMAC. Gabriella has a list of outlines.

SIT-209 Updates

- Archive didn't go as smooth as past, but all of 2020 data has been uploaded to FamWeb.
- No major changes to application.
- Update for NextGen had 1st meeting for requirements gathering contractor with Zantech(?). Should have couple more meetings next week, then start getting user community involved to go over what we'd like the new program to look like in the future.
