- general support from parent committee

Incident and Position Standards Committee Status

- comments back from parent committee; no BIG red flags, minor incl:
- reduce the "other training suggested" to critical needs
 - Narrow down to just trainings related to ARCH/READ work
 - ARCH (keep)
 - N-9042
 - S-290
 - IS-800
 - BAER
 - REAF (keep)
 - S-290

 - REAC (keep)

 - ICS-400
- I vs W/RX: general agreement that these can be done on any incident
- Biggie: **Required course must be NWCG** (N-9042; Lead READ; Fire ARCH)
 - Alt 1: submit all for NWCG and keep required
 - Alt 2: move courses to suggested; then get NWCG course approval & re-add later
 - Alt 3? (need to vet with parent committee): Move through PTB & NWCG approval concurrently (Need to vet with parent committee)

Resource Advisor Subcommittee (READSC)

- Alt 4? (need to vet with parent committee): move forward with READ/REAF plus N-9042; then move ARCH & Fire ARCH course and REAC / Lead READ course
- What does NWCG “submittal package” look like?
 - Linn: no good answer yet from NWCG on full package

- Course Status
 - N-9042
 - Cedar: NPS has developed content (PP, lectures) for Learning Portal Copyright / photo attribution for virtual could be a lift
 - Current NPS content does not include objectives, curriculum outline or timeframe; Cedar thinks 2-3 days to develop
 - Heidi: N-9042 is ready to push out virtually on large scale
 - Cedar can share what NPS has in learning portal; but no course outline/objectives
 - Linn: wants to vet NPS course; be inclusive of FS, BLM voices & goals
 - Cedar does not want to delay PTB coming out
 - Linn doesn't want to drop N-9042 to get PTB out; the course is well-established; wants consistency in training
 - Cedar: would virtual class be only format for course?
 - General agreement that N-9042 could be taught virtually OR in-person; virtual would not be required
 - Lead READ /ARCH
 - Linn: outline, curriculum set; no objectives yet; smaller cadres to teach; all materials available for review on Google Drive:

 - Heidi: Fire ARCH / Lead READ not yet platformed for large roll out
 - Tim: need NWCG parent committee to comment of which pathway is realistic
 - Courtney: willing to lead up putting together course packages, once we have NWCG requirements

- Possible research topic: waterbar vs recontour
 - What helps will reveg? Erosion?
